Agree or not, one can only hope that bipartisan collaboration on GOOD causes will always be GOOD politics. In that vein, let's provide an easy building block; something easy to get behind regardless of party:

Supporting the country's efforts to cure childhood cancer.

The [Pediatric Cancer Caucus](#) was launched in June 2009 by Representative [Joe Sestak](#) and Representative [Michael McCaul](#), to:

"serve as a clearinghouse for information on pediatric cancer and a bipartisan forum to aid members of Congress in working together to address pediatric cancer. The caucus strives to raise awareness about pediatric cancer and advocate in support of measures to prevent the pain, suffering and long-term effects of childhood cancers and ultimately eliminate cancer as a threat to all children."

Last week the Caucus facilitated the inaugural briefing to Congress which represented the largest collection of childhood cancer experts ever assembled before Congress. In addition to the representatives mentioned in the PAC2 [Report on the Pediatric Cancer Caucus - September 16, 2010](#) [[Jim Moran \(VA\)](#) and [Jackie Speier \(CA\)](#)] the following representatives attended: Reps Heath [Shuler](#) (D-NC), [Walter Jones](#), (R-NC), [Howard Coble](#) (R-NC), [Chris Van Hollen](#) (D-MD), [Marsha Blackburn](#) (R-TN) plus numerous staff from the Hill.

As of September 20, 2010 there are only 77 members of the House (the Caucus is for House members only) that have joined the Pediatric Cancer Caucus. Increasing the membership of the Caucus will aid bipartisan support for its efforts including:

1. [The Creating Hope Act of 2010](#);
2. The Childhood Cancer Survivorship Research and [Quality of Life Act](#);
3. Re-authorization of the Best Pharmaceuticals for Children Act;
4. Full funding of the Caroline Pryce Walker Conquer Childhood Cancer Act; and,
5. The creation of a Childhood Cancer Study Section within the National Cancer Institute.
