# Main Report

This report will correspond to the ecommerce scam video meant to advertise the product. I will make timestamps of all questionable claims, pseudoscientific and false statements that show up in the video. I will do my best to help the consumer see that this product is a scam that will not cure anything.

## **0:00 – 6:54**

The story starts in a very tragic way where a dad suffering from severe tinnitus is holding a gun to his head ready to commit suicide. This is a common theme in many tinnitus related ecommerce scams. The father chose not to shoot himself because his son was watching him in horror. The father is devastated that no one can relate to tinnitus and his suffering. He admits the obvious that doctors don't care. Later on the story changes the narrative from the father's pity to the medical establishment not knowing the "truth" in quotations.

## **6:59-8:00**

The narrator dishonestly says tinnitus has nothing to do with ears because it is usually triggered by hearing loss, but following they do point out science facts of tinnitus being in the auditory brain. For the most part this "[phantom hearing model](#)" is a scientifically accurate depiction of tinnitus. Most ecommerce scams don't get this right. Just because these scammers have a basic description of the science of tinnitus does **NOT** mean they have a cure.

Real scientist that know way more about the base and etiology of tinnitus do not profess to have a cure and you should be extremely skeptical of a cure coming from a shady website like this.

## **14:00-14:30 and 14:30 – 16:55**

The authors tinnitus drastically increases in volume after he slips and falls on a hard tile floor at work. His tinnitus stays drastic and no one (including his wife) understands. He is hopeless with debilitating tinnitus. He also reports some hearing loss and needs people to repeat themselves.

### **16:55-17:40**

Christmas morning his kids are watching morning Christmas carols on TV on an extra loud volume. The father becomes agitated by the noise and in a fit of rage grabs the remote throws it at the TV and the TV smashes into pieces. The wife storms out and scolds him for letting tinnitus related rage get the best of him.

### **17:35 -18:00**

The wife says she is going to take the kid and leave him. The husband with tinnitus is utterly helpless.

### **18:17-18:30**

The husband (narrator) is holding a gun to his head ready for suicide and the kid cries which intervenes the scenario and stops him.

### **18:30-25:18**

The husband dives deep into medical journals determined to find a cure for tinnitus. Doing research he suggest he should meet a scientist named Dr. Banes who researches sound therapies and which allegedly reduce tinnitus by “resetting a part in the brain”. Dr. Banes allegedly helped thousands of people. We then hear stories of the author testing hundreds of audio files on a computer hoping to find the special sound that will neurologically “reset” his tinnitus. No two people have the same reset so the audio software has to tailor it custom for each tinnitus sufferer.

### **25:20-25:50**

The author is successful and created several 10 minute tracks that allegedly will help his tinnitus. It worked and his tinnitus drops significantly and it is permanent (in fiction). His auditory cortex reset was successful

**26:00-28:50**

The process about auditory cortex reset is explained by the author.

**28:56-29:40**

Tinnitus Free System sound therapy is introduced as a sound therapy that resets the auditory brain (auditory cortex) and allegedly cures tinnitus. Within a month tinnitus will be history they claim. All you have to do is listen to high pitch sound therapy everyday for 10 minutes. It presents itself as a no effort protocol. It also comes with software the user downloads.

**30:00-30:02**

Lie that 34,973 people used this method and were cured of tinnitus. This is a classic hallmark of many ecommerce scams to make five digit cure claims, as well as know the exact number of people treated down to the last two digits which would be virtually impossible.

**It's no wonder that 34,973 people and  
counting report such a dramatic success...**

**30:20-34:30**

Rhetoric attempting to appeal to desperation of tinnitus sufferers. They claim the price could go up very soon. They claim a money back guarantee.

# Debunking Pseudoscience

In the real world scientist at the [University of Michigan](#) and [Neuromod](#) company are working on audio devices like this to lower the volume of tinnitus. Neuromod's Lenire device is already available to the public In most of the UK. Yes, the scammers got it right. Usually high frequencies can reduce tinnitus in some individuals **VERY SHORT TERM**. However the scientist combine high pitch audio stimulation with fine tuned electrical shocks to the users facial nerves to get longevity out of it. [As science is suggesting that the auditory cortex can be stimulated through the facial nerves](#) and tongue. This 'zappy' medical device + high pitch audio therapy still has mixed results.

So as I understand even [scientist with decades of research in top universities are struggling to treat tinnitus for everyone](#). What makes you think these ecommerce scammers got it all figured out before the actual scientist? There are also so many other examples of people [failing to get money back guarantees from these websites](#). Why Should you trust them? Without facial nerve stimulation like Lenire and Michigan University it's not expected one will get anymore then very short term relief. (10 minutes ect..)

## A dual-stimulus approach to treating tinnitus

The approach, called targeted bimodal auditory-somatosensory stimulation, involves two senses. The device plays a sound into the ears, alternating it with precisely timed, mild electrical pulses delivered to the cheek or neck.

## Authors thoughts

Well like I said this *\*could* provide very short term relief but it would be no different then watching tinnitus relief related videos on Youtube with headphones on. I am extremely skeptical and doubtful that this will cure anyone's tinnitus and in the science section above I explained why. Due to the fact that this company hired copywriters to make a fake story, lied about 34,000 people being cured and having such a shady website I will have to conclude Tinnitus Free System is a **scam**. Though I will give the devil his due as they do not have fake testimonials like most other scams I reviewed.

I think it is better you listen to tinnitus relief/binaural beats videos on Youtube and see if you get any luck rather then download suspicious audio software from a shady website as it might be unsafe. Digital safety from malware and viruses is very important to me as well. Please take my warning and avoid this product. I have also heard allegations that this product is being spammed by paid affiliates on tinnitus support Facebook and Instagram pages so once again that is another red flag because of the paid shills. Once again you can enjoy countless sound therapy videos on Youtube that will probably do exactly the same thing. So no need to get near the Tinnitus Free System Scam.
