Introduction and Regulations

St. Louis County Department of Parks and Recreation along with Laumeier Sculpture Park have undertaken an assessment over the past year of a collection of Ernest Trova works owned by St. Louis County. In keeping with Laumeier's mission and practice as an art museum that does not collect in depth, it was determined that five of these works would remain on loan to the Museum and installed in the Park.

The assessment further proposes to deaccession and sell from the St. Louis County holdings 27 Trova sculptures based upon the sculptures' significance, the representation of Mr. Trova's career and evolution of his design and upon the uniqueness of representation of series of works throughout his career. The review was undertaken by experts in the field and with the intention of providing the best stewardship for both the deaccessioned and remaining pieces.

Therefore, St. Louis County Department of Parks and Recreation is accepting written proposals for the acquisition of these 27 pieces by other parties. This request for proposals will be governed by the following regulations:

- 1. Preference will be given to proposals wherein preservation of the object is of the highest priority.
- Objects are available as is, where is, with no guarantee as to their condition or fitness.
- 3. Proposals to acquire the objects may be made by non-profit organizations, individuals, companies, and other parties.
- 4. Receiving parties will be responsible for all costs and arrangements related to removing the objects from their current locations.
- All title, rights, and interests in the objects will be transferred by St. Louis County to the receiving parties, which shall agree to warrant and defend St. Louis County and said described asset against all and every claim and person or persons whomsoever.

Proposals should contain the following information:

- 1. Name of organization, company, or individual and contact information
- 2. Name of the object(s) for which the proposal is being made
- 3. Intended use of the object
- 4. Preliminary and basic outline of plans to transport the object
- 5. Offer amount or trade offer if applicable

The following timelines shall apply to this request for proposals:

July 15, 2012: Written proposals due by mail or email to St. Louis County

August 15, 2012: Awards of objects made

October 2, 2012: Payment due in full

October 10, 2012: Objects must be removed from current locations or agreement is considered null and void and payments will not be returned without written authorization from St. Louis County for an extension.

It appears water causes that effect. Overall this sculpture is structurally sound; however the corrosion affecting the structure needs to be addressed before it becomes problematic.

Conservation History:

In 1997, Commercial Blasting sandblasted, primed and painted the sculpture. This piece was on loan at two different institutions. When it was on loan at one of the institutions a plate became detached from the sculpture. There is no record of reattachment, but that has been performed. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

This sculpture was on loan at an institution for ten years and was returned in 1993 due to its deteriorated condition. It was placed in the Gatehouse at Laumeier for safe storage; no repairs were made to the piece. Routine maintenance calls for annual washing with mild detergent and water, as well as an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

Registrar files at Laumeier indicate that the sculpture was repainted, but there are no specific details. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

General Condition: Good

Slight gouges and grime was found on the front plane. Pitting from previous corrosion was also found. Overall this sculpture is structurally sound and in good condition.

Conservation History:

In 1980, the sculpture was fastened to a steel plate for stabilization and sprayed with marine varnish. In 2007, Commercial Blasting blast cleaned, weathered, primed bottoms and applied clear coat on sculpture. The piece was on loan twenty-five years ago at one institution. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

General Condition: Poor

Clear coat is discolored in small areas from corrosion migrating down the sculpture. It appears that water causes this effect. Clear coat has faded due to direct sunlight. Significant corrosion occurs at the base of the sculpture. Significant pitting has occurred at the base from overexposure of stagnant water. The sculpture should be installed at slight tilt and not leveled. Overall the issues regarding this sculpture require prompt attention before they become irreparable and affect its structure.

Conservation History:

In 1994, sculpture was conserved by Commercial Blasting, no specific details are recorded. In 2006, the sculpture was blasted clean of paint and primer and then allowed to rust, and no clear coat was applied. However, in 2007 Commercial Blasting did put a clear coat on the surface. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

General Condition: Poor

Sculpture was found to have two broken welds. One of which affects the structure. There was significant corrosion found on the base. In areas exposed to direct sunlight, the clear coat on the sculpture is fading. Clear coat is discolored in small areas from corrosion migrating down the sculpture. It appears that water causes this effect. This sculpture was constructed from thin metal that had been overexposed to the elements, and therefore was more susceptible to corroding throughout. Bearing this in mind, this sculpture requires an interior site. Overall the issues regarding this sculpture require prompt attention before they become irreparable, and affect its structure.

Conservation History:

Registrar files at Laumeier indicate record of the sculpture blasted clean of paint and primer. The sculpture was allowed to obtain a slight rust patina and coated with clear epoxy in 2006. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

Corrosion was noted on base and along joints. Paint was chipped and blistered at the base. Grime was located on surface. Overall this sculpture is structurally sound; however the corrosion affecting the structure needs to be addressed before it becomes problematic.

Conservation History:

This piece was on loan at one institution. In 1983, Davlan Engineering conserved the sculpture and removed and coated inside with linseed oil. Holes were patched. The sculpture was coated with kromik primer and painted black. Registrar files at Laumeier indicate that in 2000, Commercial Blasting conserved the sculpture, but no specific details are recorded. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.

Conservation History:

The piece has been on loan at Innsbrook resort and conference center since 1997. In 1997, the sculpture underwent a treatment that consisted of blended acid passivation coupled with a controlled removal of ferric deposits assisted by stainless polishing wool in grain. Light nutrarinse washing diluted with distilled water to follow. Final rinsing in distilled water, and cotton cloth drying. Surface preservation treatment. Mounting hardware cleaned and reapplied. Routine maintenance calls for semi-annual washing with mild detergent and water as needed accompanied by an application of clear paste wax, buffing to uniform sheen. Also leaves, grass clippings and debris that come into contact with the sculpture surface should be removed.
