

## Changes to WUI EA

1. Updated the following figures using new or revised GIS data provided by the Tribe:
  - a. Created a new figure using the Landownership data and labeled it Figure 3-1.
  - b. Updated the Vegetation Communities figure and changed this to Figure 3-2.
  - c. Updated Figure 1-2 using the new roads layer and aerial image. All figures need to have the aerial image where applicable.
  - d. Updated figures 1-1, 1-2, 2-1, 2-2 using the new aerial image.
2. Section 3.2.1 Structures/Density - updated to reflect new Census Bureau data from 2000 to 2010.
3. Section 3.4 – Topography, Slope, Aspect, Elevation - Added in Photograph #1.
4. Section 3.5.2 - Changed title from “Noxious Weeds” to “Invasive Weeds”.
5. Section 3.5.4 – Threatened and Endangered Species - Updated to reflect revisions made to listed species per the California Natural Diversity Database (CNDDDB).
6. Section 3.6 – Soils and water resources. Added in Photographs 2 & 3. Photographs show a dry creek bed in the WUI Planning Area.
7. Section 3.8 – Recreation - Added in Photograph 4 showing ATV tracks.
8. Section 3.9 – Aesthetics – Added in Photographs 5, 6, & 7 showing an overview of the planning area from a hill top.
9. Section 3.11 – Community - Updated section per new Census Bureau data from 2000 to 2010.
10. Section 4.2.4 – Ecology - Updated information to be consistent with the updated information in Section 3. No impact analysis was changed.
11. Section 4.3.4 – Ecology - In the vegetation analysis, added in the following sentence:  
“The continued use of these abandoned firebreaks by off road vehicles will also limit the revegetation of these areas as well.”

If this is correct, then we need to understand how many, if any, comments were received. Based on the previous Project Manager's notes, it is my understanding that you were going to gather the comments and send to us. If you got any comments, I do not have them.
