## Meeting called to order at 10:06am

-Melanie, president of the club, welcomed everyone to the meeting. Introductions by those present was made.

## Suspended meeting for guest speaker

- Hernan Botero introduced himself as the quest speaker. He represents Beachside Environmental and gave a presentation and handed out information on beach cleaning. Residents were interested in possible ways to get the seaweed off the beach. Hernan cleans the sand at Beachside Village and other beaches on the island.

-Those present discussed the pros and cons. The rules for getting a permit had been streamlined and was no longer a long, expensive process. The 2014 cleaning rate stated by Mr. Botero was based on a one year contract and was priced at \$90 weekly, \$110/biweekly, \$150/monthly. It was noted that studies showed that the healthiest beaches were not raked. The vegetation line was just 50 ft. from the present location of the seaweed. Some residents expressed concern about disturbing the present vegetation on the beach to put seaweed on the dune. Those who rent expressed a need for a clean beach for the enjoyment of their renters.

## Called meeting back to order

-It was moved and seconded that we take nominations for 2014 officers and the following were nominated, and seconded:

-Bobby Jo Carter introduced herself. She owns a sign shop and is willing to work with us on needed signs in the subdivision. She suggested: more speed signs, make upright leaning signs, keep off dunes signs, street signs needed on 3005 per txdot rules. She volunteered to work up signage proposals for the club. Melanie suggested ordinance signs for the beach including leash and poop scoop signs.

-treasury report- \$10,400 in the bank. It was explained that this money was raised by Palm Beach for neighborhood improvements like dune walkovers, and not for frivolous spending such as parties. Dues were for that and \$550/yr. WIGPO dues. Dues or fund raising could be used for beaching cleaning. We are a 501C organization.

-Melanie had purchased a Roberts rules of order book to donate to the club.

-trash cans on the beach. The more that call the city and complain, the sooner we will get some. People could go to council meeting and raise a stink.

-hurricane meetings: Jamaica Beach, Saturday June 21 at 10am at their fire dept. City of Galveston, Wednesday May 28 at the convention center. Starts at 5pm with beach demo and moves inside at 6pm. -turtle season – April 1 to July 30. Turtle number: 1-866-887-8535.

-new members – dues are \$50/yr. – voluntary.

At this point it was moved, seconded, and voted to suspend Roberts's rules of order to vote 2 items:

-a motion to elect new officers was made. it was moved seconded and voted to elect the officers who were nominated at the beginning of the meeting

-a motion to get more information and a bid to clean the seaweed off the beach was made and seconded. On a vote of the members present is was defeated.
