Dear Mr. Shaton:

RE: project vital for civilization

I am an independent researcher, PhD, an Israeli citizen, 76. I have recently applied to Prof. Dr. Helga Nowotny, the ERC President, seeking a special program to support my project aimed at reforming modern science, which, as an analysis shows, is vital for the destiny of civilization, that of the Jewish people in particular. In response, some unidentified ERC official recommended me to apply to the NCP in Israel, which I think inappropriate, because the project is incompatible with the current ERC programs. Nevertheless, I have decided to consult you about possible solutions to the problem, proposing some measures in this regard.

The above project is based on my 30-year-long independent research in systems theory and theoretical physics that has initiated the reform of modern physics and, owing to its new method, paved the way to the reform of modern science in general, including humanities. Four parts of the research were published in the Indian Journal of Theoretical Physics (1996-2005, Calcutta). In 2007, living in Britain, I printed privately the whole research as a book and in 2008 registered it in the Copyright Office. In 2009 I printed its second edition and sent dozens of its copies to universities, institutes and research centers the world over, thus preparing the world scientific community for the new reality in physics. Despite the overwhelming results of the research, however, it has not been officially recognized yet; moreover, I have not received any response concerning the subject matter of the research. I suspect boycott and blockade.

As to the reform of modern science, the only world organization that could and MUST lead such a reform is UNESCO. However, UNESCO, as well as the major scientific centers and universities, seems to be thoroughly paralyzed by scientific establishment resisting any reform. For that reason, two years ago I launched my own website, the Reform Science Center, aimed at coordinating the reform of modern science; I have even managed to proceed with the reform on my own creating the frameworks for the sciences of politics and economics. However, such a mission cannot hinge long on the enthusiasm of a pensioner, but needs support and organized participation of the whole scientific community.

To proceed with the reform of science in an adequate way, STIMULATING AND DIRECTING THE RESPECTIVE RESEARCH THE WORLD OVER, it is necessary to establish an INTERNATIONAL CENTER OF REFORM SCIENCE, or a similar institution, under the auspices of UNESCO; naturally, given my above experience, I could head such an institution to put the reform on track and prepare younger researchers to substitute me when necessary.

Considering the role of the ERC in this respect, it is necessary to take into account that last century the European establishment, protecting their privileges, initiated two world wars, with the Holocaust for the Jewish people, and now again, resisting the necessary reforms in science and society, they have involved civilization into a new crisis threatening the very existence of humankind. This means that the European world leadership cannot be taken for granted any longer.

In this connection, with the destiny of civilization being at stake, would you please consider the following measures to advance the realization of the above project:

(1) organize an official evaluation of my above work in theoretical physics by a group of independent researchers and possibly organize its defense as a doctorate thesis, which I have failed

to do on my own;

(2) organize an official evaluation of my above short works in politics and economics that could hardly be published by European journals;

(3) on the basis of the above evaluation, make a case at UNESCO for establishing in Europe the International Center of Reform Science under the auspices of UNESCO, with myself as its director.
