Dear EASAC Administration,

I am an independent researcher, PhD, an Israeli citizen, currently a pensioner, 80. I apply to you in connection with my independent research, its scientific and social importance and the futility of my innumerable efforts to get recognition for it in Europe and receive conditions to start implementing the project based on it.

During my decades-long independent research in systems theory and physics, that I started 45 years ago in Russia and since 1992 have proceeded with in Israel, Europe and Canada, surprisingly for myself, due to its radically new method, I achieved the following:

- (1) reformed modern theoretical physics;
- (2) discovered the true philosophy of science: the true systems theory;
- (3) created the frameworks of the true sciences of politics and economics;
- (4) worked out a methodology suitable for reforming modern science in general.

As events suggest, civilization has been experiencing a general ideological crisis, the crisis now threatening the very existence of humankind. In the course of my above research, it became clear that underlying that crisis is the crises of modern science, philosophy and religion. Thus, to resolve this general crisis, it is necessary to reform the above three spheres. I have started such a reform, launched a dedicated website and achieved significant results, but such a historic mission cannot hinge long on the enthusiasm of a pensioner - it needs a broad international support. So is the mission of my project.

At present I have been seeking an opportunity to establish a new scientific center, an NGO (7-10 persons), possibly in Switzerland, committed to the above mission and sponsored for two years, at least; its main tasks being as follows:

- (1) attracting highly professional researchers and philosophers worldwide to start reforming science in their fields of interest using my methodology;
- (2) attracting philosophers of religion to create the science of religion suitable for universities;
- (3) raising a fund to run the center and stimulate the researchers.

For several years however I have been fruitlessly trying to get recognition of my above research and conditions to start implementing the project. Analyzing my whole experience in this regard, I have arrived at the conclusion that, since my immigration in Israel (July 1992), Russian agents, notorious for their methods and devices in treating their former fellow-citizens, have initiated a conspiracy against me with their Israeli and some European counterparts with the aim of isolating me thoroughly from the scientific community.

So, adding the traditional European nationalistic prejudices, my independent status, and the present level of corruption of the scientific establishment, wherever I go now to Europe for my mission, I achieve at best boycott, without any mention of my research, as if it had not existed at all. Such is the case now in Switzerland, where, October 27, I applied to the University of Zurich for assistance in my mission and encountered a cold, unwelcome reception. But such a treatment of the research of a potentially historic importance, vital for the destiny of the whole civilization, is not an option,

not simply a violation of ethics, a nuance in conduct: it is a most dangerous misconduct fraught with a crime against humanity, an existential threat to civilization, and should be treated respectively, perhaps at The Hague.

IN THIS CONNECTION WOULD YOU PLEASE FIND THE PROPER SOLUTION TO THE ABOVE PROBLEM CONVENING IF NECESSARY AN INTERNATIONAL COMMISSION TO CONSIDER ALL ITS ASPECTS.
