Future Land Use Classification:

Motion by M. Lahti, second by S. Rantala to recommend to the Town Board a change in the Future Land Use classification of the SW SW section 29 to Forestry – Limited Residential Motion carried unanimously by voice vote.

Special Use Permit – Dan and Dana Olson request a special use permit for residence in A-1 – conversion in the SW¼ of SW¼ S29T48NR9W. Parcel I.D. number 04-038-2-48-09-29-303-000-10000. Acreage: 30.3 acres. Zoning District: A-1

Special Use Permit application:

- ▶ A 30.3 acre parcel in the SW1/4 of SW1/4 of section 29
- > Place a residence in an existing and permitted pole building
- Parcel is zoned Agriculture
- Owner: Dan and Dana Olson

Findings:

- A new parcel was recently created when the subject parcel was incorporated with the other 9.7 acre parcel in this 40 acres, hence the SWSW parcel was recreated.
- The 2 previous parcels had 2 different Future Land Use classes: Forestry Core and Rural Moderate Residential
- > The previous 9.7 acre parcel has an existing residence
- > Hence the Special Use application is for a second residence in the new parcel
- The Plan Commission has recommended that the new parcel should have one Future Land Use classification: Forestry Limited Residential
- ➢ Forestry Limited Residential class allows for 1 residential complex per 10 acres
- This Forestry Limited Residential Future Land Use classification will accommodate the existing residence and the proposed new residence on the newly created parcel

Planning Commission Resolution Recommending Adoption of the Comprehensive Plan of the Town of Oulu

WHEREAS, the Town Board of the Town of Oulu, Bayfield County, Wisconsin has created a Town of Oulu Plan Commission and charged it with preparing a comprehensive plan for the Town of Oulu, and

WHEREAS, a Comprehensive Plan of the Town of Oulu that contains all of the elements (with a land use element that includes a series of maps that shows current and future land uses) specified in section 66.1001(2) of the Wisconsin Statutes has been prepared, and

WHEREAS, the Town of Oulu has held a public hearing on the Comprehensive Plan of the Town of Oulu, and

NOW, THEREFORE BE IT RESOLVED, that the Town of Oulu Plan Commission does hereby approve and recommend the adoption of the Comprehensive Plan of the Town of Oulu, Bayfield County, Wisconsin by the Town Board of the Town of Oulu, Bayfield County, Wisconsin.
