- This year we encountered 2 floods one in May and one on Labor Day that created a lot of washouts.
- Washouts were repaired (graveled) on East View, south Muskeg, south Hoover Line, Wallin, Range Line, Kaukamo roads and the shoulders on Airport Road.
- Repaired culverts on Hoover Line, Range Line, Wallin and East View roads.
- Brushed and ditched roads.
- Reconstructed North Muskeg Road beginning at Bayfield Line and going north with 2" minus base and 3/4" topping of gravel. Also, a culvert was installed at the end of the road for a bus turn around.
- Bleachers at the park were covered with 5/4" green treated lumber.
- Sander on the truck was repaired.
- New motor was put in the park mower.
- A new grader was purchased.
- Purchased a new snowblade for the truck.
- Gravel was spread on West Colby, Hautala, East View and Hoover Line roads
- Patched blacktopped roads and also graveled portions of north Airport Road.
- Seven special use permits were approved.
