Plan Commission Report: S. Rantala

John and Stephanie Rautio's request to build a house with an attached garage. Special Use Permit application:

- ▶ For the SWNW, which is attached to the SENW in Section 34
- ➢ Total parcel size is 80 acres
- Construct a new house with attached garage
- Parcel is zoned Agriculture

Findings:

- Parcel size is 80 acres
- ▶ Future Land Use Class for the SWNW is Forestry Core
- Future Land Use Class for the SENW is Agricultural Core
- Both Forestry Core and Agricultural Core allows the maximum density of 1 building unit complex per 35 acres
- The Special Use Permit application to build a house with an attached garage on this parcel is consistent with the Zoning Classification and the Future Land Use Class for the parcel.
