

Dear Supreme Justice:

RE: robbery attempt; threat to civilization

**Preamble.** I am an independent researcher, PhD, an Israeli citizen, currently a pensioner, 80. I apply to you in connection with a crime presenting, in particular, a potential threat to the destiny of the Jewish people and civilization as a whole.

**Description of the event.** Recently I visited France and, on departure, 14.11.15, lost my computer at the CDG-1 airport. On my request, the computer was found, and the Bagages Du Monde company undertook to deliver it to me in Israel. I submitted all the necessary documents and paid 150 euro for the delivery. But the delivery seems to have been intercepted by some UPS shipping company that later, 26.11.15, informed me of that and sent me its tracking reference number: 1ZV198V60498357324. The same day, however, the UPS, or somebody else on its behalf, called me and demanded 570 shekel for the delivery, allegedly a custom duty. The custom invoice, however, contained false data about myself and my item. I informed the UPS about the mistake and the fact that my computer purchased in Israel was exempt of custom control. But the UPS seems to have refused to take my objection into account, stopped responding sincerely and had not yet delivered my computer to me. So I suspect an attempt of robbery of the computer and theft of its valuable scientific information – my decades-long independent research in exact sciences and humanities, in particular, and other personal information.

**Character of the event.** Remarkably, that robbery was perpetrated openly, calmly, like a legal business, with a professionally fabricated false document, without any fear of retribution, as if it were a confiscation of property of an especially dangerous criminal or a daily Auschwitz business. The character of the event suggests that there is perhaps no civilized laws in Israel, thus throwing shade on its statehood. I suspect the army of Russian agents, in particular, the people controlling my hostel, spying me everywhere and waging an omnipresent war against me. I have several times applied to the government of Israel and the Knesset for assistance in this respect, but in vain.

**Consequences of the event.** My mission before that event was aimed at reforming modern science, philosophy and religion, for which I developed the proper methodology. Such a reform, as my analysis suggests, is necessary to overcome the present general ideological crisis of civilization now threatening the very existence of humankind. That reform would be especially useful for the Jewish people experiencing now a deep, existential ideological crisis. My mission was unique, with no precedent of that kind known so far. Without the computer and its amount of respective information, however, I will have to abandon that mission, temporarily or for good.

**Conclusion.** In this connection would you please:

- (1) take measures to return me my computer;
- (2) in case of the computer having been returned to me, have the UPS company compensate me for the illegal seizure of my computer and keeping it for over three weeks without delivery, on the one hand, and for the damage to my dignity and security inflicted by the UPS repeated, skilled attempts to deceive me, in particular with a professionally fabricated false document carrying my name and my ID number, on the other hand, by \$250,000 (two hundred fifty thousand US dollar);
- (3) in case of non-returning my computer to me, have the UPS company compensate me for the robbery of the computer with its valuable scientific information and for the above mentioned damage to my dignity and security by \$500,000 (five hundred thousand US dollar);
