

**Participation Waiver & Registration Form For Events Held at Trudeau's Park & Trudeau's Resort & Banquet Hall and Neighbouring Properties.**

**June 16, 17, 18, 2017**

Please read any waiver carefully. It includes a release of liability and waiver of legal rights and deprives you of the ability to sue certain parties. Do not agree to this document unless you have read and understood it in its entirety. By agreeing, you acknowledge that you have both read and understood the text presented to you as part of the registration process. You also understand and agree that events carry certain inherent dangers and risks, which may or may not be readily foreseeable, including without limitation personal injury, property damage or death. Your ability to participate in the event(s) is/are subject to your agreement to the waiver and by agreeing herein, you accept and agree to the terms of the waiver and release agreement.

I, \_\_\_\_\_ agree to respect the Event Grounds, keep my campsite clean and respect other participants and campers' space. I assume all responsibility for my personal welfare and personal property under any and all circumstances at all times. I understand that Trudeau's Resort & Banquet Hall, also known as Trudeau's Park, Venue Grounds and neighboring property may contain rough terrain. I need/will exercise caution to maintain my health and safety at all times. I understand that I am responsible for any fees or charges for this event to be paid to the organizer(s) of this event. By indicating your acceptance, you understand and agree as follows. In exchange for being allowed to participate in the DOOMSDAY DASH event (and camping where available, all of which are called the "Event"), agree and acknowledge as follows (if participant is a minor or under disability, must be signed, agreed and acknowledged by parent or legal guardian.):

**\* INITIAL ON EACH LINE AFTER READING \***

1. DOOMSDAY DASH - TRUDEAU'S RESORT (it's owners and staff and volunteers) is conducting an event called DOOMSDAY DASH. I will run, climb, crawl, hurdle, jump, duck, spring and take any other actions to complete an obstacle course / running event in existing weather, good or bad. During this race event, I will encounter staff and volunteers who pose as "Marauders" who I will have to engage with in combat in order to pass certain obstacles and check points. They have been instructed to create resistance and challenge without deliberately causing any serious injury. Runners are instructed not to cause any serious injury to the staff. \_\_\_\_\_
2. I understand that overnight or other camping may also be available. If I participate in camping, I will do so only in designated areas, in a lawful and safe manner and with proper equipment, and I will obey all signs, notices and directives (including those regarding noise, hours, conduct, campfires and other matters.) I will not use, possess or loan to other any dangerous devices (including weapons, firearms, or fireworks). I understand that camping in the designated area is at my own risk, that lighting conditions may vary and that ground may not be level. I am responsible for providing my own safety gear and appropriate clothing to stay warm, dry and safe. \_\_\_\_\_
3. I know the Event activities (including the racing portion, all aspects of an after-party, shopping and camping) are potentially dangerous and that I could be injured or even killed, but I accept them anyway and assume all risks ( including the inherent danger of the Event; the negligence or intentional acts of any person including myself, inadequate wearing apparel; dangerous ground conditions, spectator interference, natural causes and all other causes of injury, damage or loss). If I am injured, I will not make any claim against 1709882 Ontario Inc. or the venue and neighbouring property where the race is being held. I will also indemnify (reimburse) 1709882 Ontario Inc. and or the venue if any other person makes a claim against it for anything that I did. \_\_\_\_\_
4. I understand that Doomsday Dash and the venue do not provide medical services or insurance and that my fee is non-refundable and does not include these benefits. \_\_\_\_\_
5. I know that the Event will be conducted on land not belonging to Doomsday Dash and that because they may not be familiar with any dangerous conditions there, it has no duty to warn me. This is an event that focuses on overcoming challenging terrain that may be dangerous and I understand and accept that fact as a participant in this Event. \_\_\_\_\_
6. I will at all times conduct myself in a careful manner, will not injure or damage any other person or property and will obey all laws, Event Rules and Event Staff (including security personnel engaged by Doomsday Dash). I will not while racing be under the influence of any alcohol, drug or substance nor consume any of these. \_\_\_\_\_
7. I do not have any mental, physical, or other health conditions which would make my participation in the Event inadvisable or dangerous. \_\_\_\_\_
8. If I am injured or have any other type of loss or damage (including theft of personal property from my vehicle or bag check area, or from my person), I will not make any claim against Doomsday Dash, Property Owners, 1709882 Ontario Inc or the venue. I will also indemnify (reimburse) 1709882 Ontario Inc. and or the venue if any other person makes a claim against it for anything I did. \_\_\_\_\_
9. I hereby authorize Doomsday Dash and 1709882 Ontario Inc. to record my voice, photograph and record (on film, tape, photographs or otherwise) my performance and participation in the Event, To edit the same at it's discretion and to include it with the performances of others with sound effects, special effects and music; to incorporate the same into commercials, advertisements, films, trailers or other programs related to the Event; to use and to license others to use such records and photographs in any manner or media whatsoever, including without limitation unrestricted use for purposes of publicity, advertising and sales promotion and to use my name, likeness, voice, biography or other information concerning me in connection with the Event, commercial tie-ups, merchandising and for any other purpose associated with the Event. I further acknowledge that 1709882 Ontario Inc owns all rights to the results and proceeds of my services rendered in connection herewith. \_\_\_\_\_
10. Participant age requirements: I acknowledge that I will be 14 years old or older by the morning of my selected race date. You must be 18 years of age or the parent / legal guardian of a minor under 18 or an incapacitated or mentally challenged person in order to agree to this document. \_\_\_\_\_
11. Location transfer policy; I understand that I cannot transfer my participant registration to another location. I also understand that I will not be refunded for a participant ticket. I may transfer my ticket to another participant for this event for another party who signs their own waiver but THERE ARE NO REFUNDS FOR AN EVENT TICKET AND I MAY NOT TRANSFER THAT TICKET FOR MYSELF OR ANY OTHER PARTY TO ANOTHER EVENT. \_\_\_\_\_

SUMMARY: I UNDERSTAND THAT THIS IS A DANGEROUS SPORTING EVENT WHERE IT IS POSSIBLE TO BE INJURED OR EVEN KILLED IF I CHOOSE TO PARTICIPATE. I AGREE THAT I ACCEPT ALL RISK INVOLVED FOR BOTH KNOWN AND UNKNOWN HAZARDS DURING THE EVENT. I AGREE NOT TO SUE OR PURSUE ANY LEGAL ACTION AGAINST DOOMSDAY DASH, 1709882 ONTARIO INC. NEIGHBOURING PROPERTY OWNERS, MUNICIPALITY OF TWEED OR THE VENUE FOR ANY INJURY, PERSONAL LOSS OF ANY SORT, INCLUDING PROPERTY LOSS OR DAMAGE. UNDERSTAND AND ACKNOWLEDGE THAT ALL FEES AND ASSOCIATED COSTS PAID IN REGISTRATION FOR THIS EVENT ARE NOT REFUNDABLE FOR ANY REASON, UNDER ANY CIRCUMSTANCES INCLUDING BUT NOT LIMITED TO PERSONAL INJURY, SCHEDULING CONFLICTS, ACTS OF GOD (INCLUDING FIRE, FLOOD, EARTHQUAKE, STORM, HURRICANE OR OTHER NATURAL DISASTERS) AND OR EVENT CANCELLATION. \_\_\_\_\_

Trudeau (collectively, the "ORGANIZERS") Including the Municipality of Tweed, LIABLE FOR ANY PERSONAL INJURY, DEATH, LOSS OF OR DAMAGE TO PROPERTY (collectively, "LOSS") OCCURRING TO MYSELF, OR ANY MINOR OR PET UNDER MY CARE, AS A RESULT OF MY STAY AT THE CAMPGROUNDS, PARKING AREAS OR ENTERTAINMENT AREAS OR AS A RESULT OF ANY ACTIVITIES I AM INVOLVED WITH IN THE CAMPGROUNDS, PARKING AREAS OR ENTERTAINMENT AREAS AND I HEREBY RELEASE, ON MY OWN BEHALF AND ON BEHALF OF ANY PARTY CLAIMING THROUGH OR IN RESPECT OF ME, THE ORGANIZERS FROM ANY AND ALL LIABILITY WITH RESPECT TO ANY LOSS. \_\_\_\_\_
