RE: unique mission in concentration camp

About myself and my research

I am an independent researcher, PhD, an Israeli citizen, currently a pensioner, 80. During my almost 40-year-long independent research that I started in the late 60s in Russia and since 1992 had proceeded with in Israel, Europe and Canada, I have achieved the following:

- (1) reformed modern theoretical physics;
- (2) created the frameworks of the true sciences of politics and economics, the sciences nonexistent or underdeveloped before;
- (3) discovered the true interpretation of the General System Theory, the philosophy of science;
- (4) developed a methodology for reforming modern science in general.

Those results, if recognized officially, would amount to a turning point in the history of science and civilization. Seeking official recognition of my research, I have repeatedly applied to conferences, universities and foundations, as well as to UNESCO, but in vain. The main reasons for the above failure seem to be (1) my status of independent researcher, (2) corruption and obscurantism of European universities and (3) a conspiracy against me initiated by Russian agents and involving the Israeli and European establishment.

My mission

As my analysis shows, civilization has been experiencing a general ideological crisis now threatening the very existence of humankind. To resolve that crisis, it is necessary to reform modern science, philosophy and religion. My research opens the way to such reforms; moreover I have already started them. To proceed with that mission, however, I need an international support to set up a COORDINATING CENTER necessary to attract researchers the world over, guide and stimulate their work, and train some of them to substitute me when necessary. This my mission seems to be a truly Jewish one, the more so that it is of vital importance for the destiny of the Jewish people. Indeed, given the current new wave of antisemitism in Europe and the growth of tension between the Jews and the Palestinians in Israel, the reform of modern religion seems to be vital for the Jewish people.

As to the coordinating center, the best solution would be to reorganize UNESCO and commit it to the above mission. Another possible option is perhaps the Vatican City, taking into account Pope Francis' recent utterance in this respect. Otherwise it would be necessary to set up a new institution dedicated to the above mission. In this case, according to my preliminary estimations, it would be suffice to establish an NGO for 7-10 persons, possibly in Switzerland, and sponsor its activity for two years by about \$1,000,000, at least. Afterward it would be able to work on donations.

My conditions in Israel

For over eight years I have been living in Haifa, in a hostel controlled thoroughly by Russian agents, the type of people who had persecuted me in Russia and whom I tried to flee when immigrating in Israel. Those agents are able, in particular, to control and block all my communication channels and my internet activity, which is incompatible with my above mission. In general, they spy my every initiative and usually try to sabotage it. On top of all that, they have recently stolen my laptop computer with materials of my life-long research crucial for my current mission – an organized crime with unpredictable harmful consequences for civilization. So I wonder why, with my above research and my current world-fateful mission, should I live actually in a concentration camp controlled by that Russian gang?
