Proceedings of the Ironwood City Commission

A Regular Meeting of the Ironwood City Commission was held on March 14, 2016 at 5:30 P.M. in the Commission Chambers, Second Floor of the Municipal Memorial Building in the City of Ironwood.

A. Mayor Burchell called the regular meeting to order at 5:30 P.M.

Motion was made by Tauer, seconded by Semo and carried to excuse Commissioner Corcoran from the meeting.

B. Recording of the Roll.

ABSENT: Commissioner Corcoran (excused).

Louise Demasi, of 400 Silver Street questioned the City Commission on what the number of complaints were and how will the City enforce a no smoking policy.

Keith Johnson, of 119 E. Michigan Ave as a co-director of Festival Ironwood felt that it would be hard to enforce a no smoking policy during the festival.

LeRoy Johnson stated that the no smoking ban in 2010 dealt with confined spaces and questioned if there was even a law restricting smoking in open spaces. Further discussion of this matter took place.
