Dear Mr. President:

RE: adequate treatment of nuclear threats

I appeal to you concerning the issues vital for the destiny of civilization, the USA in particular. I am an independent researcher, an Israeli citizen, 81. During my half-life-long independent research in exact and social sciences, I have managed, for the first time, to create the framework of the true science of politics that may provide the true interpretation of historical processes and, in particular, suggest the adequate measures to treat various political problems including, for example, such as the increasing nuclear threat from North Korea.

My above work suggests that all major political problems, that of North Korea, in particular, are mealy manifestations of the present general ideological crisis. That crisis is the result of the inconsistency between the present great technological achievements and the generally archaic structure of modern society. The crisis has been developing fast toward its natural end - a new world war, most likely a nuclear one. To tackle that crisis it would be necessary to reform modern society, that is its science, philosophy, religion and education. During my research I have started such a reform, achieved significant results and developed a general methodology of the reform. Now to proceed with such a historic mission I need a strong international support. I think the new US administration would be very much interested to provide me such a support.

I need a sponsorship and a legal help to set up and run a COORDINATING CENTER (ten persons or so to begin with) necessary to attract world researchers, guide and stimulate their work (for two years at least) and prepare some of them to substitute me when necessary. The best solution would be to reorganize UNESCO and commit it to the above mission. Otherwise it would be necessary to set up a new institution, possibly in Europe or the USA, dedicated to the above mission. Conditions in Israel are absolutely incompatible with that mission, and there is no hope to change them; moreover, there is no reliable communication there. More on the matter is in the papers enclosed.

In this connection would you please consider an opportunity to provide me with the above financial and legal support, as well as with the living conditions appropriate for my above mission, in Europe or the USA.
