Dear Ms. Chief Justice:

RE: fabrication of false documents

I am an Israeli citizen, 82, an independent researcher, Candidate of Science, approximately PhD. Despite my age, I proceed with my great scientific mission, that is supposedly vital for the destiny of civilization, the destiny of the Jewish people in particular. I appeal to you in connection with two attempts by the Ministry of Interior in Haifa to provide me with false biometric documents – the Israel Passport and the ID Card, as follows.

During my visit to Greece, 27-29 May, 2018, to participate at an international philosophy conference, I lost my Israel Passport #20672278. On May 30, I applied to the Ministry of Interior in Haifa to restore my Israel Passport and renew my ID card. I paid for that NIS540.

June 11 and 13, respectively, the new Passport and ID card were delivered to me. However my signature on the passport was distorted: the letters were unnaturally tilted by about 60° relative to the vertical, while the tilt is about 30° in my natural signature. Besides my picture on the ID card was of poor quality (see copy 1 enclosed).

So I refused to accept the documents. June 21, I applied to the Ministry of Interior in Haifa again to provide me with new authentic Passport and ID card. The manager of the department promised me to issue authentic documents. I paid for that NIS 655. July 3, the new documents were delivered to me. However my signature on the Passport was again distorted in the same way (see copy 2) . That was unacceptable because no computer would recognize that graffiti as my signature.

The impudent character of those two fabrications looks sinister. I suspect involvement of Russian agents. The above development, given my above international mission, presents a threat to civilization, the Jewish people in particular.

In this connection would you please:

- (1) oblige the Ministry of Interior in Jerusalem to issue new, authentic documents to me, Passport and ID card;
- (2) oblige the Ministry of Interior in Jerusalem to compensate me for the material and moral damage inflicted on me by the above repeated deliberate fabrication of false documents;
- (3) taking into account my above great international mission, on the one hand, and the fact that the aggression of Russian agents against me is dangerously escalating, on the other hand, recommend the Knesset to provide me with the proper conditions for my life and my mission in Israel, or otherwise help me emigrate to the USA.
