- 7. Items for Discussion and Consideration:
 - a. Discuss and consider the approval of the Financial Report: Director Bergman presented the financial report and explained the reason why the DIDA is in the red.

Motion by Lovelace, to approve the financial report. Second by Nosal. Motion Passed 6 to 0.

b. MCACA Grant Letter and Contract: Director Bergman presented the contract.

Motion by Nosal, to approve the grant agreement. Second by Zak. Motion Passed 6 to 0.

- c. Update on Pocket Park: Director Bergman said that the trees have been trimmed and nothing new has happened. If the plan is to not do the sculpture, then the DIDA will need its money returned.
- d. Snow Shovel Contract: Director Bergman presented the snow shoveling contract for the pocket park and the art park. Burchell brought up the mowing of the art park.

Motion by Lovelace, to approve the snow shoveling contract. **Second** by Zak. Motion Passed 6 to 0.

- e. Jack Frost Festival and Discussion on Northern Elves Festival: Emily Burchell the project director for the Northern Elves Festival presented her ideas and her website. The proceeds from any fundraising activities will go toward the Ironwood Chamber of Commerce. Director Meyer with the Ironwood Chamber of Commerce had many questions related to cross promotion, insurance for the events and so forth.
