Dear Ms. Azoulay:

RE: appeal to UNESCO mandate

I am an Israeli citizen, 84, an independent researcher, PhD, currently a pensioner. In the course of my almost 40-year-long research in exact sciences and humanities, I have achieved the following:

- (1) reformed modern Theoretical Physics;
- (2) found the true interpretation of the General System Theory;
- (3) created the frameworks of the true sciences of Politics and Economics.

In my opinion, these results, not officially recognized yet, amount to a turning point in the history of science and civilization.

The above results have encouraged and enabled me to start settling the present General Ideological Crisis now threatening the very existence of humankind. To that end, it would be necessary to reform the ideology of modern society, that is modern science, philosophy and religion. Fortunately, I have already started such a reform and worked out a general methodology for it. However, to proceed with that mission on a large scale, I need a broad international support.

Seeking support for that mission, I have repeatedly appealed to UNESCO, scientific and social organizations in Europe and Israel, but in vain. The main reasons for that failure were perhaps my status of independent researcher, the current corruption of European institutions, the ultra-nationalist character of Israel institutions, and Russian agents' omnipresent sabotage activity against me. So, as perhaps the last resort, I have decided to appeal to UNESCO again.

In this connection, taking into account that, with the above general crisis, civilization has been approaching a military and ecological catastrophe, that UNESCO, by the spirit of its mandate, is the first to blame for that global risk and the first to take measures to remove it, would you please consider a possibility to establish a new UNESCO institute committed to settling the above crisis, assigning me possibly its director.
