

The country's fragile health care system coupled with insecurity, population movements, densely populated areas, and low access to clean water, poor sanitation and hygiene facilities mean that there is a high risk for rapid spread of COVID-19 while the health system will be unable to manage it.

Objective: Reduce morbidity and mortality, as well as protection threats and incidences for the most vulnerable as a

result of COVID-19, through integrated health and water, sanitation & hygiene (WASH) interventions.

Activities: Provide essential life-saving health and water, sanitation, and hygiene services

Duration: 18 August 2020 – 31 March 2021

Project Context

South Sudan, the world's youngest country, has suffered crisis after crisis: sustained insecurity, mass displacement, recurring natural disasters, a desert locust infestation, a severe economic crisis, and now the COVID-19 outbreak. 7.5 million people, more than two thirds of the population, need humanitarian assistance and protection.

Juba, the country's capital, is the current epicenter of the COVID-19 outbreak in South Sudan, being the main entry point to South Sudan and with the high population density. The capacity of the health system in Juba to manage the projected large caseload is severely limited and will heavily rely on support from the humanitarian sector.



- 2,592 COVID-19 cases registered on September 15 the actual number may well be higher, given severe limitations in sample taking and testing.
- If limited resources are shifted away from critical health and nutrition services, it can lead to increased illness and death from other diseases such as malaria, diarrhoea and vaccine-preventable diseases.
- Decreased access to already limited reproductive health services could result in complications and deaths for mothers and their new-borns¹.
- COVID-19 and movement restrictions enhance the burden on households and increase risk for gender-based violence. Support for survivors of gender-based violence, including psychological first aid and clinical management of rape, is crucial during any crisis.
- Mental Health and Psychosocial Support services are limited in South Sudan, but their need is expected to
 increase as the COVID-19 pandemic causes fear, stigma, and isolation, and could be a potential trigger for other
 mental health problems like depression, stress, and anxiety.

Key figures:

- An estimated 56 % of the population has no access to primary health care services.²
- A mere **34** % of households have access to a safe and improved water source less than 30 minutes distance from their home.
- Only 19 % of households use improved sanitation facilities, including shared facilities.
- A little as 20 % of at-risk women and girls have access to gender-based violence service.

Our Response:

Activities, Beneficiaries, Outcomes

Responding to the COVID-19 outbreak in South Sudan, Medair's Emergency Response Team provides health and water, sanitation & hygiene (WASH) services with integrated elements of protection to vulnerable communities in the capital Juba. Medair prioritises support to health facilities in Juba and their catchment areas and remote case management for COVID-19 patients and their households in isolation.



10 Health facilities support



- 14,000 outpatient consultations for suspected or confirmed COVID-19 patients.
- 50 health workers trained on essential health topics, protection mainstreaming, gender-based violence, psychological first aid and related COVID-19 adaptations.
- 10 health facilities equipped to treat survivors of gender-based violence.



Improved access to clean sanitation facilities in health facilities

- 14,000 people provided with functional handwashing facilities with clean water and soap or 0.05% chlorine solution
- 500 vulnerable people provided with access to dignified, safe, and clean sanitation.



Kit distributions for households with vulnerable family members³

1,000 households receiving non-food-items for quarantine or isolation.



Prevention and training activities



Increasing community awareness of COVID-19 preventive measures through Risk Communication and Community Engagement

- 80,000 people received COVID-19 related risk communication messaging.
- 320 community health and hygiene promoters identified and trained.



Access to safe water and personal hygiene, including handwashing

- 39,000 people provided with access to safe drinking water, including handwashing
- 3,000 vulnerable women/girls of menstrual age in schools and/or community equipped with menstrual hygiene management kits



Remote support and Covid-19 case management



- 16,200 suspected or confirmed COVID-19 patients receive remote support.
- 30 staff trained on remote medical support, health and hygiene promotion, protection mainstreaming and psychosocial support.
- >80% of beneficiaries report a positive response on satisfaction with accessing Medair 's services.
