 - i. The City is waiting on the final report. The trail will be a multi-use trail according to the application.
 - b. Update on Mountain Bike Trail Development in Miners Memorial Heritage Park.
 - i. The trail building company subcontracted to a trail designer. Bergman along with Miners Park Reps met with the designer when he was here.

The designer did not complete the full design and will get that wrapped up in the Spring.

- c. Update on Curry Park upgrade phase 2.
 - i. The project agreement is complete and will be getting bids for the coming summer.
- d. Norrie Park Renovation and Montreal River Water Trail.
 - i. The map for the project is being worked on.
- II. Strategy 5.4(a) Strengthen and Implement the Master Plan for Miners Memorial Heritage Park (MMHP).
 - a. Kangas stated that the board election has happened. They are currently working on equipment and some events. This item will change to Miners Park update.

- A. Mt. Zion Rural Development Grant.
 - I. The Gogebic Range Health Foundation received a grant for a trail system planning grant for Mt. Zion. The City of Ironwood and Gogebic Community College were involved with the project. The City will apply for a rural development grant to get \$100,000 for a grant.
