4/15/2024 LISA- EMAIL FROM HEATHER:

In the above case, the Trustee objected to underfunding and to the disparate treatment of the student loans versus the general pool of creditors.

Here is what I am thinking/wondering: I personally do not think the debt underlying POC 7 is a student loan under the Code that would make the debt non-dischargeable. I think this makes a difference not only as to dischargeability but also to the disparate treatment argument you raise.

My calculations show if we do not separately classify POC 7 to be paid in full, then the general pool of creditors get close to 20% assuming no other large claims come in (bar date is in about a week). NOTE, though, that the Debtor has both filed her return and paid the IRS debt in full and sent us proof of that, so I anticipate an extra \$4,993.00 in funding once the claim is amended (which I have requested). That then takes anticipated distribution to 25%.

So my questions for you are:

1. Can we agree that if IRS claim amended to \$0.00 AND
2. POC 7 not separately classified

Leading to a distribution to unsecured creditors of 20-25% or so, that would address both your disparate treatment/funding arguments?

I am going to need to continue confirmation likely in order to give us time to work through this, though. Is that agreeable, marking paragraph 5?

REPLY BY REJ:

Yes. Let's cont, marking 5 to work through this. When I looked at this Wednesday I didn't take into account the IRS issue. Once bar date passes and IRS issue resolved we can more accurately determine funding.

4/10/2024 LISA- OBJ BY TRUSTEE:

Internal Revenue Service has filed an estimated claim number four in the amount of \$4,993.00. The debtor has filed the 2023 tax return and paid the tax liability. The Trustee recommends the debtor object to the claim asking for the claim to be disallowed.

To the extent any inchoate or future interest or other post-petition asset is disclosed, the property should revest in the debtor only to the extent it is now exempt or could be claimed as exempt once realized.

The plan is underfunded and will not pay the dividend noticed. The Trustee recommends the debtor increase funding to pay the noticed dividend or re-notice creditors for the correct dividend.

Unfair classification: The plan proposes to pay student loans in full, while providing a minimal dividend to allowed unsecured claims. The Trustee submits the Debtor should increase funding to pay a higher pool to allowed unsecured claims.
