#### Hire Highway Patrolman:

### Gravel Specs:

Gravel specs – Motion by Nieder, second by Hamilton for the clerk to advertise for 2,500 yards of grade 2, 3/4" gravel (in accordance with DOT specifications) and include provision for residents to purchase gravel at the bid price. Bids will be opened at the June 9, 2018 meeting. Motion carried unanimously by voice vote.

#### Assessor:

Motion by Hamilton, second by Nieder to approve the addendum to the assessor's contract to include \$500 per year for three years for the insertion of all data on paper record cards into the MarketDrive software database. Absent: None. Motion carried unanimously by voice vote.

## **Usage of Park Property:**

#### Road Projects:
