Roads - 50/50 split agreement:

Park Infrastructure Grant proposal:

Purchase of Road Groomer:

Discussion was held on the purchase of a road groomer for the roads. Joe Doskey, from Road Groom Manufacturing presented his proposal. Motion by Hamilton, second by Nieder to purchase a 11' groomer. Motion carried by voice vote.

Purchase of plow for pickup:

Mike Davidson, town employee had contacted Rob's Plow Services regarding a plow for the pickup truck. Tabled until the January meeting and until additional information is obtained.

FEMA Claim:
