

The “FALL OF LISA BELLOW Flash Giveaway” Sweepstakes

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

Sweepstakes may only be entered in or from the 50 United States and the District of Columbia and entries originating from any other jurisdiction are not eligible for entry. This Sweepstakes is governed exclusively by the laws of the United States. You are not authorized to participate in the Sweepstakes if you are not located within the 50 United States or the District of Columbia.

1. How to Enter. During the Sweepstakes Period (defined below), [follow @simonbooks, like the “FALL OF LISA BELLOW Giveaway” Instagram, comment to tag a friend.] via one of the following methods [CONFIRM ALL STEPS]:

- (i) **Via Instagram:** Access the Instagram application on your mobile device, and follow the links and instructions to become a follower of @simonbooks. You must make sure the “Photos Are Private” option in the account settings on your Instagram account are set to “OFF”. You must have an Instagram app and account to enter via this method. If you do not have the Instagram app, you may download it through the application store on your device. The Instagram app is free.

If you choose to enter via Facebook, Twitter or Instagram using your mobile device, standard data fees may apply. You should consult your wireless service provider's pricing plan for details. You agree to incur any and all charges demanded by your wireless carrier. You should also check your device's features for capabilities and check the device manual for specific use instructions.

If an Instagram entrant is a potential winner, he/she will be notified by a direct message and/or by Sponsor posting a comment to the potential winner's Submission on his/her Instagram account.
