RE: SEAGO/SVMPO JOINT REGIONALSHSP UPDATE

The SEAGO/SVMPO Joint Regional Strategic Highway Safety Plan was approved by the SEAGO Executive Board on August 17, 2018. The SHSP is now complete. The plan is available at: https://www.seago.org/strategic-highway-safety-plan.

Our consultant will be shipping digital copies of the plan this week. They should be available for distribution at our TAC meeting.

The plan has resulted in several successful HSIP applications. In 2017, Cochise County was awarded \$624,156 (Design and Construction) for safety improvements on Charleston Road. In addition, Sierra Vista received \$939,000 for Phase 1 funding for a systemic adaptive signal control project. In August 2018 ADOT announced FY 22-23 project awards, with Cochise County, Santa Cruz County, and Graham County projects being funded in the amount of \$4,410,000 for safety projects (design and construction) in their counties. We invested approximately \$400,000 in the plan and have secured \$5,973,156 in HSIP funding to date.

ADOT plans to issue another request for HSIP applications in early 2019, with approximately \$80 million in funding for fiscal years 2023 and 2024.

Over the next month, SEAGO will be updating the plan's crash data tables to reflect 2017 crashes. The data will be provided to the TAC prior to our November TAC meeting.

At our January meeting, we will rank high priority HSIP locations/corridors for the 2019 HSIP application cycle.

At our March TAC meeting, we will review 2019 HSIP applications for placement in the Future Project Section of our TIP. This is a necessary step for the applications to proceed to ADOT.

RE: LTAP TRAINING

SEAGO annually programs \$10,000 in STP funding to the Local Technical Assistance Program (LTAP). The \$10,000 covers the membership costs for all of our member agencies. If we did not fund the program, the cost to each agency would be \$100 per transportation employee. An agency with 12 employees dedicated to transportation would pay \$1,200 per year to be a member of LTAP. As a member we have access to the following services:

- 1. No fee access to any LTAP training provided at any location in the State.
- 2. The ability to request localized on-demand training for any course offered by LTAP.
- 3. No fee access to their equipment loan program (retroreflectometer and turning movement counters).
- 4. No-fee access to their technical assistance program. Upon request, LTAP will provide a subject matter expert to assist local agencies with road construction, maintenance, and administrative issues.

As you may recall, at our July 2017 TAC meeting, we had some members express concern about the value of funding LTAP. We continued the discussion at our September 2017 TAC meeting. At that meeting, the members present voted unanimously to continue to fund the program. The TAC also agreed that LTAP local training requests be scheduled through SEAGO. This is because of our ability to provide a central training location and conduct outreach to all member agencies to fill the class size mandates.

In general, LTAP offers two certificate programs:

Level I Road Scholar: Training courses are targeted for entry-level transportation employees, or those with no or limited experience (i.e., up to five years experience in the transportation field).

Level II Road Scholar: Training courses are targeted for employees working within transportation industry, motivated to advance their knowledge, skills and abilities to excel their career. Level II training is in the beginning supervisory level and management course work. (Up to 10 years field experience).

The TAC agreed that SEAGO led training should focus on Level I course work during the first year.

Prior to our November 2017 TAC meeting, SEAGO distributed a Regional Training Needs Survey to the TAC. SEAGO received 12 replies to the survey. 11 of the 12 respondents indicated a need for a regional training program. The other response indicated not sure. All 12 respondents indicated that they would send staff to a central training location.

The top 3 courses identified through the survey and staff discussion were Maintenance Math, Signing and Striping 1, and Introduction to Survey and Grade Checking. SEAGO hosted a Maintenance Math course on 5/16/18. It was well received with 22 attendees.

In February, SEAGO distributed a Heavy Equipment Training Needs Survey to the TAC. We had a total of 9 responses (Clifton, Benson, Safford, Patagonia, Tombstone, Douglas, Bisbee, Thatcher, and Santa Cruz County). A majority indicated that they would participate in heavy equipment training. Safford, Bisbee, and Santa Cruz indicated that they would be willing to host a training course. After review of the survey results, the TAC identified the backhoe and front end loader as the first courses to be pursued.

The survey identified the best months for training to be in priority order:

- 1. January
- 2. December
- 3. February
- 4. November
- 5. October
- 6. March

Prior to moving forward with scheduling training, I will be seeking answers to the following questions:

- 1. Are we still interested in a LTAP Regional Training Program?
- 2. Are we still interested in pursuing LTAP Level 1 coursework?
- 3. If so, do we keep Signing and Striping 1, and Introduction to Survey and Grade Checking?
- 3. Are we still interested in pursuing heavy equipment training?
- 4. If so, are Safford, Bisbee, Santa Cruz County willing to sponsor the training?
- 5. Are January, December, and February still the best months to schedule training?
