In 2023, the SouthEastern Arizona Governments Organization (SEAGO) was awarded a \$500,000 U.S. Environmental Protection Agency (EPA) grant to support the assessment, cleanup planning, and revitalization of publicly and privately-owned properties (sites). The communities eligible to use the grant include the cities of Clifton, Nogales, Patagonia, and Safford and all other communities in the counties of Santa Cruz, Greenlee and Graham. Grant funds can be used to complete Phase I and II Environmental Site Assessments (ESAs), cleanup planning, and a variety of property reuse planning activities. Funding will be available for use on a first come, first served basis through September 30, 2027.
