## **FINDINGS**

### **CLASSIFICATION OF ALLEGATION**

**Allegation #1 – SUSTAINED** – Committed a criminal act.

**Allegation #2 – SUSTAINED** – Arrested for Impersonating a Public Servant.

**Allegation #3 – SUSTAINED** – Improper action causing a police response.

### **CONCLUSION**

Based on the testimonial, documentary, and video evidence collected during the course of this investigation, **Allegation #1**, stating on December 10, 2021, Senior Corporal Frederick Frazier, #7324, committed the criminal act of criminal mischief, is classified as **“SUSTAINED.”**

On March 30, 2022, Mr. Chabot emailed the Internal Affairs Division with information suggesting that Senior Corporal Frazier was under criminal investigation.

McKinney Police Department Incident and Supplemental Report #21-010711 documented on December 10, 2021, Mr. Chabot reported a Criminal Mischief offense of a political sign. A silver Ford F-150 was observed entering the parking lot of the 7Eleven, a male exited the vehicle and cut down Mr. Chabot’s sign.

Texas Department of Public Safety Texas Rangers Incident/Investigation Report #2022I-TRB-50084294 documented the initial investigation was started by the McKinney Police Department on December 1, 2021, and Senior Corporal Frazier was discovered to be a suspect. The report supported the McKinney Police Departments’ initial investigation of Criminal Mischief on December 10, 2021.

On December 10, 2021, Senior Corporal Frederick Frazier was observed on surveillance camera arriving at the 7Eleven convenience store in a silver Ford

F-150. Senior Corporal Frazier exited the vehicle, cut the zip ties of a political sign, and threw the sign to the ground. Senior Corporal Frazier re-enters the vehicle and leaves the location.



As a result of his actions, Senior Corporal Frazier should be held accountable for the following rule violation:

Senior Corporal Frazier violated the aforementioned rule when he committed the criminal act of Criminal Mischief.

Based upon the testimonial and documentary evidence collected during the course of this investigation, **Allegation #2**, stating on June 24, 2022, Senior Corporal Frederick Frazier, #7324, brought discredit to the department when he was arrested for impersonating a public servant, is classified as **“SUSTAINED.”**

On June 23, 2022, Senior Corporal Frazier received two True Bill of Indictments from Grand Jury of Collin County, for Impersonating a Public Servant on cause #219-82366-2022 (Walmart) and cause #219-82367-2022. On June 24, 2022, two felony warrants were executed for Senior Corporal Frazier’s arrest, and he turned himself into the Richardson Police Department.

Senior Corporal Frazier violated the aforementioned rule on June 24, 2022, he was arrested for two counts of Impersonating a Public Servant.

Between December 1, 2021, and February 9, 2022, the McKinney Police Department responded to multiple incidents involving Senior Corporal Frazier. After determining Senior Corporal Frazier was a Texas State Representative District 61 candidate and former McKinney City Councilman, the investigation was turned over to the Texas Rangers for potential criminal violations.

McKinney Police Department Incident and Supplemental Reports #21-010513 document a police response to Walmart on December 1, 3, and 7, 2021, regarding potential criminal acts caused by Senior Corporal Frazier. McKinney Police Department Incident and Supplemental Report #21-010711 documents a police response a 7Eleven on December 10, 2021, regarding a potential criminal mischief offense caused by Senior Corporal Frazier. McKinney Police Department Incident and Supplemental Report #21-010854 documents a police response to RaceTrac on December 14, 2021, regarding more potential criminal acts caused by Senior Corporal Frazier.

On February 9, 2022, Senior Corporal Frazier contacted the manager for TeaLatte Bar regarding a political sign on the property. On February 10, 2022,

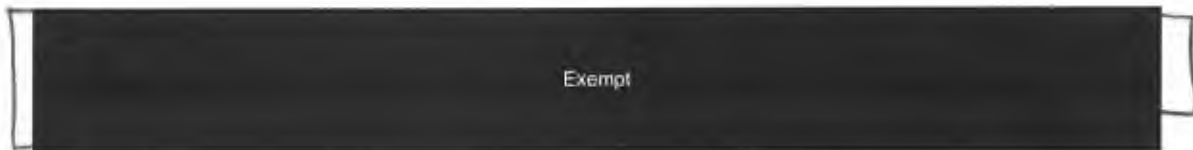

Texas Ranger Wallace responded to the TeaLatte Bar and met with Mr. Nguyen regarding a potential criminal act caused by Senior Corporal Frazier.

On June 23, 2022, Senior Corporal Frazier received two True Bill of Indictments from Grand Jury of Collin County, for Impersonating a Public Servant on cause #219-82366-2022 (Walmart) and cause #219-82367-2022 (TeaLatte Bar).

Surveillance video documents Senior Corporal Frazier at Walmart, 7Eleven, and RaceTrac prior to the police responses.

## Dallas Police Department Code of Conduct

### Chapter IV

Revised 10/13/2020

#### **PROFESSIONAL CONDUCT AND PERSONAL BEARING**

- 4.1 Dereliction of duty on the part of any employee, detrimental to the proper performance of the functions of the Department, is cause for corrective action. The following subsections constitute dereliction of duty.
- A. Failure of a supervisor or commander to immediately take action when a violation of rules or regulations comes to their attention, regardless of the supervisor's or violator's assignment or rank within the Department.
  - B. Failure to deliver to the official departmental custodian any property found by, confiscated by, or relinquished to officers of this Department without undue delay and, in any event, before their tour of duty is ended.
  - C. Failure to place evidence in its officially designated place for preservation and storage.
  - D. Failure to take appropriate police action to aid a fellow peace officer exposed to danger or in a situation where danger might be impending.
  - E. Cowardice or failures to perform police duties because of danger.
  - F. Any action that places any person in greater danger than is necessary for the proper performance of the employee's duties.
  - G. To offer, agree to accept/deliver, or solicit a bribe. (A bribe shall be defined as a gift, emolument, money, thing of value, testimonial, appointment or personal advantage, or the promise or solicitation of same for the purpose of obtaining special privileges or personal gain by the donor or other person.)
  - H. For the purpose of protecting life and property, officers will always be considered on duty while in the City of Dallas and shall be prepared to act to the extent possible any time circumstances indicate their services are required.
- The above enforcement action will not include:
- 1. Enforcement of laws of a Class C Misdemeanor nature or traffic enforcement when out of uniform and off-duty unless in an off-duty employment capacity and with prior supervisory permission.
  - 2. Enforcement responsibilities beyond the ability of the officer when he is not armed. (Appropriate action in such cases may include calling 911.)
- 4.2 No employee shall be convicted of, nor commit, any act or omission which is defined as a criminal act.
- 4.3 No employee shall engage in any conduct which adversely affects the morale or efficiency of the Department or which has a tendency to adversely affect, lower or destroy public respect and confidence in the Department or officer.
- 4.4 No employee, when acting outside the course and scope of their duties, shall precipitate, cause, or escalate a disturbance or police incident to their discredit.
- 4.5 No employee shall fail or deliberately refuse to obey a lawful order given by a supervisory member including any order relayed from a superior by an employee of same or lesser rank.
- 4.6 Employees shall treat supervisory members, subordinates, and associates with respect. They shall be courteous and civil at all times in their relationships with one another.
- 4.7 Employees shall not publicly criticize or ridicule the Department, its policies, or other employees by talking, writing, or expressing in a manner which:
- A. Is defamatory.
  - B. Is obscene.
  - C. Is unlawful; or
  - D. Impairs the operation of the Department by interfering with its efficiency, by interfering with the ability of supervisors to maintain discipline, or by exhibiting a reckless disregard for the truth.
- 4.8 No employee shall be under the influence of drugs or be a user of drugs when such drugs are not prescribed by a physician or dentist or to take drugs in a manner not prescribed by a physician or dentist.

Frederick Frazier, the Republican candidate for Texas House District 61, has been charged with impersonating a public servant, a third-degree felony, after an investigation over accusations of sign-stealing during his campaign.

A Collin County grand jury handed up its indictment of Frazier, a Dallas police officer, on Thursday. Frazier turned himself in to the Richardson police department Friday, according to his lawyer, Robert Rogers.

The indictment comes as the result of an investigation by the state Department of Public Safety. The agency could not immediately be reached for comment.

WFAA-TV (Channel 8) reported that Frazier's opponent in the GOP runoff, Paul Chabot, reported to McKinney police a December incident in which some of his campaign signs were removed from outside a Walmart.

Chabot told the station that the store notified him that someone who said they were a McKinney code compliance officer asked the store to tell Chabot that his signs were not in compliance. A city manager later told him that no code compliance officer had been to the store, however.

One of his signs was taken from the area near the store days later, WFAA reported.

Dallas police said the department was notified of the indictment Friday and placed Frazier on administrative leave.

Frazier has been a law enforcement officer 27 years, Rogers said. He received an endorsement from former President Donald Trump in February and emerged from the primary victorious over two other candidates.

In fast-growing Collin County, three Republicans vie for new House District 61 seat

Frazier's campaign said in a written statement that Chabot was trying to overturn the results of the runoff election, which Frazier won decisively.

"Frederick Frazier is looking forward to having the opportunity to defend himself in court, where we are confident that jurors will see through Chabot's lies in the same way that voters have five times before," the campaign said.

Chabot wrote in a Facebook post that Frazier had run "one of the most dishonest campaigns I have ever seen."

# Republican Texas House candidate in Collin County charged with impersonating public servant

Frederick Frazier's runoff opponent accused him of posing as a city code compliance officer to get campaign signs taken down. Frazier said his opponent is to blame in the case.

A Texas House candidate and police officer backed by former President Donald Trump and top Texas Republicans has been indicted on a charge of impersonating a public servant, according to authorities.

Dallas police said Friday that Frederick Frazier was placed on administrative leave after the department was notified that a Collin County grand jury indicted him. Impersonating a public servant is a third-degree felony.

Frazier turned himself in to the Richardson jail Friday and posted bond, said Teddy Yoshida, a spokesperson for the Richardson Police Department.

It is unclear what the specific allegations against Frazier are, and a spokesperson for the Collin County district attorney's office was not immediately available for comment.

Responding to the indictment, Frazier's campaign blamed his Republican primary runoff opponent, Paul Chabot, who had suggested Frazier posed as a city code compliance officer to get Chabot's campaign signs taken down at a Walmart. In a statement, Frazier's campaign said Chabot, who has run for office multiple times before, is "trying to overturn the results of that election by bringing up trumped complaints to law enforcement and testifying before a grand jury."

"Frederick Frazier is looking forward to having the opportunity to defend himself in court, where we are confident jurors will see through Chabot's lies in the same way that voters have five times before," the statement said.

John Thomas, Chabot's consultant, issued a statement on Frazier's indictment:

"An independent grand jury was empaneled and determined that Mr. Frazier committed multiple felonies. In fact, it was the Rangers and the McKinney PD who uncovered the felonies. Frazier's lying and deceit knows no limits. He committed crimes and refuses to fess up. He is a disgrace to himself and to those

who dawn a badge in law enforcement. Paul Chabot demands Frazier have one shred of decency and immediately drop out of the race as it's crucial that both a Republican and candidate with integrity represent the people of the 61st district."

Frazier easily won the Republican primary runoff last month for House District 61, an open seat in Collin County that leans Republican. A well-known advocate for law enforcement in Austin, Frazier had the backing of Trump, Gov. Greg Abbott, Lt. Gov. Dan Patrick and state House Speaker Dade Phelan. The Democratic nominee in the race is Sheena King.

During the runoff, Chabot spoke out about the alleged theft of dozens of his campaign signs. In one incident, Chabot said a Walmart store manager told him someone claiming to work for city code compliance came in and told the store to take down Chabot's signs because they were illegally placed. Chabot said he reported that to the police.

The Texas Rangers ultimately looked into his claims. Chabot later obtained a report from the Rangers through a public records request that said the agency investigated Frazier in February for "alleged criminal violations ... of Impersonating a Public Servant and potentially related Theft."
