### 3. RESIDENCE, 140-142 BEAUDRY

It was the unanimous decision of the Poard that future investigation would be instigated prior to making final determination as to whether or not the structure qualifies for declaration as a Historic-Cultural Monument.

#### MEW BUSINESS

#### 1. PESIDENCE, 1325 NORTH GARDNER STREET

President Dentzel read communication of November 22, 1972 from Mr. Kenton Redelings requesting the C.R.B.'s consideration in declaring his residence as a Historic-Cultural Monument. The Board members reviewed a photograph of the building and Dr. Winter indicated that its style of architecture, California Craftsman Bungalow, was very prevalent during the turn of the century and up to World War I. He expressed the opinion that the style of architecture should be provided recognition and; thereupon

MOTION: Dr. Winter moved, seconded by Mrs. Pallette, that the C.H.B. take under consideration the request received from Mr. Kenton Redelings and investigate the possibility of declaring the residence at 1325 North Gardner Street as a Historic-Cultural Monument worthy of preservation; which motion was unanimously adopted. AYES: Sullivan, Tolford, Pallette, Winter, and President Dentzel. NOES: None.

## 2. SENATE BILL NO. 357 (NOT ON PRINTED AGENDA)

President Dentzel referred to receipt of notification from Raymond Girvigian, F.A.I.A., to the effect that Senate Bill No. 357 has finally passed the State Assembly and is awaiting the signature of Governor Reagan. President Dentzel indicated that since this legislation would provide protection for some of the most significant historical landmarks, he had authorized a letter to be forwarded on behalf of the C.H.B. urging the Governor sign this Senate Bill. The Board members wholeheartedly concurred with the action taken by the President.

Extensive discussion ensued relative to the provisions of this Senate Bill permitting assessing of qualified privately owned historical properties on the basis of the value attributed to the uses of the property permitted under contract for a minimum of 20 years. It was noted that the State Department of Parks and Recreation is to adopt rules and regulations concerning criteria for qualified historical properties and that the State Board of Equalization will be required to adopt rules and regulations concerning the valuation of such property for purposes of property taxation.

The Board members also discussed the extensive cooperation received from Senator Mills through his sponsorship of the Mill which was instigated by the California Council, A.I.A. Preservation Committee.

MOTION: Dr. Winter moved, seconded by Mr. Tolford that the C.H.B. forward letter of appreciation to State Senator Mills, President Pro Tempore of the Senate, for his most valuable assistance in connection with the recent passing of Senate Bill No. 357 on taxation for historic landmarks; which motion was unanimously adopted. AYES: Sullivan, Pallette, Tolford, Winter, and President Dentzel. NOES: None.

Motion: Mrs. Pallette moved, seconded by Mrs. Sullivan, that the C.H.B. forward a letter of commendation and appreciation to Raymond Girvigian, F.A.I.A., for his valiant efforts which resulted in the passing of Senate Bill No. 357; which motion was unanimously adopted. AYES: Tolford, Winter, Sullivan, Pallette, and President Dentzel. MoES: None.
