
**Why did Pastor Stuart Latimer suddenly leave Covenant in Aug-Sept 2007?**

Pastor Stuart Latimer letter to Austin Davis – Nov 2, 2005: *“I am sorry that you were offended by my non-response to your previous letter (which you sent twice). The entire pastoral staff agreed that I should not respond the first time you sent it, and we agreed on a minimal response the second time which I drafted but neglected to send. Your problem Austin is not with me-- it is with the entire pastoral staff and the session. We stand united in our belief in the authority of the Word of God and our belief in how the gospel should be applied as we counsel and interact with marriages in crisis.”*



Austin Davis letter to Stuart Latimer – Dec 1, 2005: *“For the past several years, I have tried to bring relevant information and my concerns to you in a gentle, respectful manner. In recent months, I attended your marriage class by the Providence of God and listened to you teach on the power of the tongue’s destruction and the meaning of adultery as it relates to emotional abandonment and destruction. Upon hearing your interpretation and teaching of the scriptures, I was convicted in my heart to plead with your sense of right and wrong regarding the harm you have caused members of our congregation. This was not an easy decision to make because I am weary in my soul from contending with my fellow brethren over issues I strongly believe in regarding the integrity and the purity of the church. Despite the fact that you are a high authority in our church, I felt that it was important for you to spiritually reflect upon the consequences of your actions and the teachings you continue to espouse as a pastor.”* Question: Did Stuart Latimer, Jack Foster, Larry Ferris, or Jim Bachmann ever have a protected “clergy privilege” confessional relationship with child-molester John Perry and/or Susan Ann Perry via Covenant marriage counseling?

Dear Pastors, Elders, and Deacons:

The Book of Church Order defines the role of a deacon as: "It is the duty of the deacons to minister to those who are in need, to the sick, to the friendless, and to any who may be in distress."

I write this letter to you in regard to a member of our congregation, Mr. Greg Lurie.

I am grieved in my soul by the marriage dissolution now taking place affecting Mr. Lurie's family.

I also have some concerns with the assaults on his Christian character that have occurred during the past two years. Five accusations against him remain most grave and serious in nature:

- 1) Mr. Lurie attempted to murder his wife by running her down with his SUV.
- 2) Mr. Lurie has physically abused his children.
- 3) Mr. Lurie has committed sexual misconduct in his marriage.
- 4) Mr. Lurie does not love his wife and children, has abandoned them, and has not provided for them financially.
- 5) Mr. Lurie has a borderline personality disorder and his psychiatric problems have remained dangerously untreated.

The Holy Scriptures (Galatians 6:1) provide the Church with wisdom if indeed these allegations are true: "Brethren, if a man is overtaken in any trespass, you who are spiritual restore such a one in the spirit of gentleness, considering yourself lest you also be tempted."

In the event the accusations are deemed to be slander, the Book of Church Order has provided a judicious process to protect the Church from public dishonor and scandal.

In particular, Part II of the Book of Church Order is entitled, "The Rules of Discipline."

I would recommend the following provisions be studied for spiritual discernment: 1) Part II – Chapter 31-2; 2) Part II – Chapter 31-8; 3) Part II – Chapter 31-9; 4) Part II – Chapter 32-17.

In closing, the position of Presbyter or Elder is a dignified, shepherding office within the Church. The Book of Church Order defines the primary role of an Elder to include the following charge: "To watch diligently over the flock committed to their charge, that no corruption of doctrine or morals enter therein." I know that this matter has been before you during the past two years and I pray the Lord will continue to grant you wisdom as you deliberate Mr. Lurie's future standing as a member of Covenant Presbyterian Church.

To Whom It May Concern:

I have known Mr. Greg Lurie for over ten years and was asked by the Session of his church to provide an assessment to be used in facilitating marital reconciliation. I have reviewed occupational testing provided by Mr. Lurie as well as the results of personality testing done at AGAPE. I have also met with Mr. Lurie on several occasions as well as having numerous telephone conversations with him. The function of my assessment was to facilitate their joint marital counseling, which was unfortunately unsuccessful.

Mr. Lurie currently has joint custody of his children. I understand that his ex-wife is now requesting supervised visitation instead of the previously agreed upon standard visitation. Mr. Lurie also notes that previous correspondence by my office is being used out of context and in a way that opposes the nature and intent of my evaluation. Apparently the information is being distorted in an effort to keep him from seeing his children.

Mr. Lurie has been extremely cooperative in every aspect of his previous assessments including extensive marital counseling with Dr. Bruce McCurdy. He has also met with numerous members of his church throughout the divorce, all in an attempt to restore his marriage.

I know of absolutely no reason why Mr. Lurie should not have full visitation privileges with his children. I do not believe they are at risk of harm in any way and feel they should be allowed to see him as much as possible. Concerns that Mr. Lurie may harm the children in any way are unfounded and extremely unlikely to occur.

**Covenant Leaders knew about John Perry's child sex abuse for at least 6 years prior to Greg Lurie writing this sworn declaration for a child sex abuse cover-up lawsuit which was falsely declared to have "zero facts."**

**DECLARATION**

Under penalty of perjury, I state that I am competent to make this declaration and that this declaration is based on my own personal knowledge as follows:

In the spring (March/April) 2002, my children were placed, by Covenant Presbyterian Church, in the house of John and Susan Ann Perry without my knowledge and against my wishes.

Covenant Presbyterian Church referred to the Perry residence as a safe house and my children were placed there for approximately 30 days.

Prior to my divorce on March 31, 2004, Worrick Robinson was an attorney for my former wife, Carolyn Lurie.

On October 14, 2004, Dr. Sam Sells wrote and provided me a letter to use in a court proceeding in which Worrick Robinson was the attorney for my wife, Carolyn Lurie.

On March 4, 2007, I wrote and mailed a letter to John Perry to explain my feelings to him about the harm he had done to my family and children in 2002 when my children were placed in his safe house.

On or about mid-May 2008 until approximately mid-February 2009, I served 80 days in jail on consecutive weekends to complete my sentence imposed upon me by Judge Muriel Robinson, a relative of Worrick Robinson.

In the summer of 2013, **REDACTED** called me regarding **REDACTED** and Covenant Presbyterian Church. During that conversation, **REDACTED** told me that **RED** had been sexually molested over an extended period of time by **REDACTED** John Perry, and that the timing of John Perry's actions coincided with the same time that my children

were residing with the Perry's in the spring of 2002. REDACTED reassured me repeatedly that no wrongdoing was done to any of my children during their stay at the Perry's residence in the spring of 2002 but had no irrefutable facts to support REDclaims.

To date, no one from the Metro Police department has ever contacted me about the John Perry safe house or my children after Austin Davis provided Detective Michael Shreeve my contact information on or about December 11, 2012.

Dear Austin —

I've had time to read and reflect upon your most recent packet, parts of which you have shared with me before. As I've told you in person, it's sad that this situation has gone on so long, and that it has led to your family's departure from Covenant. One point I can clarify - and which you may have already learned - is that the fact that the church won't transfer you letter has no direct connection with any pending church discipline. Lou's letter implies a connection where none exists. In every case when someone reneges his membership, the church's position is that there is then no membership letter to transfer. The session isn't singling you out.

Dear John:

You may mean well in writing your letter to me but your letter is an additional disappointment among many. Based upon reading your thoughts, you apparently have not reflected upon my presentation of facts and evidence as thoughtfully and seriously as I had hoped for and you do not seem to comprehend (or want to comprehend) my reasons for resisting agreement with the Session regarding the abusive, slanderous, unaccountable wrongdoings the Session has committed during the past four years. Instead, you always seem more interested in finding fault with my committed stance and actions instead of finding greater fault with the conduct of those who have been entrusted with great spiritual powers within the instrument of His Holy Church. In this particular letter, you seem to be more interested in correcting me with a minor technicality (undefined by the Stated Clerk) regarding a potential "letter of transfer" and yet you ignore the deeper mean-spirited purpose of the Stated Clerk's letter which was written to put me in my place "institutionally" that I am a man under a black cloud who has resigned from the Church to avoid proper disciplinary accountability from the Session. As you (and others) have done on some occasions in the past, you seem much more interested in judging my actions and my reason for "coming back" to the Church to "carry on the conflict" as an over-passionate, angry man (as described by elders) than you are in fulfilling your own "God-called" responsibility as an officer in the Church to ensure that serious investigation(s) regarding a member(s) of your Church and PCA (i.e., Greg Lurie and possibly Steve Davis) are indeed being carried out by the Nashville and National Presbytery (see BCO Chapter 31-2 - "**however originating clause**").



<p>I talked with the pastor Jim Bachmann. He has an extensive file on the subject with the letters he has sent. They have dealt with this for six years and did not want to involve police. They made a report because he came to the location on Sunday after being officially advised not to. He sent a letter which they perceived to be threatening. Security was present on Sunday. Mr. Bachmann said they will not prosecute unless it continues. I explained the mental health options if an arrest does become necessary.</p> <p>I spoke w/ Worick Robinson, who witnessed the trespass. He said the subject was not belligerent, but was confrontational. He only felt concerned when he learned the subject asked the security officer if he had a gun. He gave me the names of the security officers - Juan Knight and Troy Stackhouse.</p> <p>I went to 5895 Willshire to speak with the suspect and his wife regarding the harassment complaint.</p> <p>Mrs. Davis spoke with me alone. Her husband was not home. She gave me history on the complaint (a subject named Greg had been accused six years earlier of issues and they did not think he was guilty. They pushed the issue but have never seen documentation that was official. No one from the church told them exactly what happened.) She said her husband is stable, has a good job, has no history of mental health issues, she is not concerned, that he's a great father, and that she is very committed to him. I discussed his fixation on this issue and that it was not reasonable to spend so much time and energy sending letters as he has done. She said she felt responsible for pushing the issue and that he'd never do it again. She was upset that it had become such a serious issue. She spoke freely. She called him to come on home so he could also speak with me.</p> <p>He arrived and I spoke with him candidly. He explained why he had felt things had been done wrong and why he felt he had to deal with the issue. He was surprised there had been such a response. We discussed that bad things do happen with church members and that society does not take a chance. I explained stalking, harassment and trespass to him. He understood and said he'd have no more contact nor go to the church. He does not want to be arrested and was very concerned that he might be later on. 



It is my charge this morning to inform you of a disciplinary action recently taken by the Session. Before doing that I will read the opening passages from the Book of Church Order Part II regarding Discipline.

**27-1.** Discipline is the exercise of authority given the Church by the Lord Jesus Christ to instruct and guide its members and to promote its purity and welfare. The term has two senses:

a. the first referring to the whole government, inspection, training, guardianship and control which the church maintains over its members, its officers and its courts;

b. the second a restricted and technical sense, signifying judicial process.

**27-2.** All baptized persons, being members of the Church are subject to its discipline and entitled to the benefits thereof.

**27-3.** The exercise of discipline is highly important and necessary. In its proper usage discipline maintains:

a. the glory of God,

b. the purity of His Church, and

c. the keeping and reclaiming of disobedient sinners. Discipline is for the purpose of godliness (I Timothy 4:7); therefore, it demands a self-examination under Scripture.

Its ends, so far as it involves judicial action, are the rebuke of offenses, the removal of scandal, the vindication of the honor of Christ, the promotion of the purity and general edification of the Church, and the spiritual good of offenders themselves.

**27-4.** The power which Christ has given the Church is for building up, and not for destruction. It is to be exercised as under a dispensation of mercy and not of wrath. As in the preaching of the Word the wicked are doctrinally separated from the good, so by discipline the Church authoritatively separates between the holy and the profane. In this it acts the part of a tender mother, correcting her children for their good, that every one of them may be presented faultless in the day of the Lord Jesus.

Having read those words, the announcement of discipline is as follows:

Whereas **John Perry** has confessed to committing heinous and repetitive sin against **REDACTED** and has not shown evidence of repentance, the Session of Covenant Presbyterian Church has declared that he is excluded from the sacraments and cut off from the fellowship of the church. The Session has taken this action with sorrow and the desire to see him repent and return to Christ and the fellowship of His church.
