



Thank you for your correspondence regarding the above Parking Charge Notice (PCN). I have considered your case carefully and have decided to reject your appeal on the following grounds:

Parking Control Management are contracted to manage the parking within this area and the Parking Charge Notice (PCN) has been issued in accordance with this parking management scheme.

This steets private land and is managed and operated by Parking Control Charge Management. The Parking Notice (PCN) has been issued in accordance with this parking management scheme. The signage in the area is clear and informs motorists of the contractual obligations you agree

to by parking in this area. By parking in this manner, you agree to pay the stated charge.



The restrictions require that a vehicle is parked in the designated parking area only. Parking is not permitted on access roads, grass verges, areas marked with cross hatched markings or areas in which parking is not designated. No vehicles can park in this position regardless of the circumstance, if the driver was unable to park inside a bay displaying a permit the alternative unrestricted parking should have been found.

Parking Control Management (UK) Ltd are under no obligation to provide evidence of a contract between ourselves and the Landowner as you are not party to this agreement. In this regard I refer to (and rely) on the decisions in the following two cases;

ParkingEve v Beavis (CA 2015), in particular LJ Moore-Bick's comments at para 29:
"In the course of argument a good deal of reliance was placed on ParkingEye's contract with the Pension Fund, under which it received no revenue from its operation of the car park if motorists adhered to the terms of the license. In my view the terms on which ParkingEye chose to contract with the Pension Fund are irrelevant" VCS v HM Revenue & Customs (2013), in particular Lord Justice Lewison's verdict at paras 21-22:

"There is no legal impediment to my contracting to sell you Buckingham Palace. If (inevitably) I fail to honour my contract then I can be sued for damages ... On the stock market it is commonplace for traders to sell short; in other words to sell shares that they do not own in the hope of buying them later at a lower price. In order to perform the contract the trader will have to acquire the required number of shares after the contract of sale is

made." Both of the above cases make it abundantly clear that the relationship between the Landowner and the parking operator is not relevant to the relationship between the parking operator and the motorist.

The cancellation provisions that you refer to under the Consumer Contracts (Information, Cancellation and Additional Payments) Regulations do not apply to this contract."

If you choose to do nothing, we will seek to recover the monies eved to us via our debt recovery procedure and may proceed with Court action against you.

Our client relies on the case of ParkingEye v Beavis 2015. In that case it was accepted as an established principle that a valid contract can be made by an offer in the form of the terms and conditions set out on the sign and accepted by the driver's actions as prescribed therein.

The signs on the Land are clear and unambiguous. By parking in the manner in which you did, the charge was properly incurred.

As the contract is between you and our client, our client does have the authority to enforce parking charges. Both VCS v HM Revenue & Customs (2013) and Parking Eye v Beavis (CA 2015) made it clear that a contracting party need not show they have a right to do what they have promised in the performance of any other contract, nor is (in the case of a parking operator) the agreement between Operator and Landowner of any relevance. In any event, and without concession, our client did have authority from the landowner to operate on the land.

The charge sought is industry standard and is set at a rate so as to suitably satisfy our dient's legitimate interest. In the case of ParkingEye v Beavis 2015 it was held that an £85.00 charge was neither extravagant nor unconscionable. The Accredited Trade Associations of which parking operators must be a member in order to apply for DVLA data prescribe a maximum charge of £100. Our client's charges are within this level. The charge is not therefore excessive.

The decision of the Supreme Court also made it clear that the charges are not penal nor do they have to be reflective of the parking operator's loss. Furthermore, they are they are entitled to be at a level that provides a deterrent effect.

As you did not pay the charge within the 28 days allowed you are in breach of contract. Breach of contract entitles the innocent party to damages as of right in addition to the parking charge incurred. As you didn't pay the charge the matter was passed to us and the debt has, as a result of this referral risen as our client's staff have spent time and material facilitating the recovery of this debt. This time could have been better spent on other elements of their business. Our client believes the costs associated with such time spent were incurred naturally as a direct result of your breach and as such claims them as a
