
Please Support Bailey's Bill on Tynwald Day - Saturday 5th July 2025



Bailey was more than a pet, he was a member of our family and taught us how to live more fully. People in Ramsey said they enjoyed seeing him out and about. To us, he was our 'boy' Bailey, while others called him "the rusty dog", or called out to him as he strode along "hello gorgeous". Bailey was nearly 15 when he passed away at home on 28th September 2024. 'Bailey's Bill' will be his Tynwald Day 2025 legacy.

Christmas 2024 will be the first Christmas since 2010 that Bailey has not graced us with his presence, but his spirit and great love of life lives on. He taught us so much and, with barely a day of illness, he made us question many old assumptions. The biggest assumption of all being the 'existence' of any 'rabies virus'.

Rabies / hydrophobia is claimed to be a 'viral' disease, from bat bites in the US, or from dog bites in Asia and Africa. There are clearly different scripts, which different paymasters demand in different locations. According to the WHO (World Health Organisation) we should also fear 'furious rabies' - characterised by hyperactivity and hallucinations, and additionally 'paralytic rabies' - characterised by paralysis and coma.

For all this, Louis Pasteur invented the first 'rabies' vaccine way back in 1885. He has a Paris Institute named after him, as a fitting place to celebrate his 'achievements'. Those 'achievements', when we study method statements of his barbaric 'experiments', are more chemical than biological and include: drilling into the heads of dogs, not providing them with food or water and tying them to posts, for days on end. The resultant 'foaming at the mouth' of these poor animals was then passed off as being caused by an imaginary 'rabies virus'; however no proof of any such 'virus' has been found right up to this day.

When we study a British veterinary Oath, we note they have an enshrined duty not to harm our pets:

The Oath of the RCVS (Royal College of Veterinary Surgeons) is interesting, in pledging loyalty to the organisation... as well as to the animals in their care. The RCVS, in exchange for the right to practice veterinary surgery in the UK, requires that every veterinary surgeon makes a declaration which, since 1st April 2021 has been: 'I PROMISE AND SOLEMNLY DECLARE that I will pursue the work of my profession with integrity and accept my responsibilities to the public, my clients, the profession and the Royal College of Veterinary Surgeons, and that, ABOVE ALL, my constant endeavour will be to ensure the health and welfare of animals committed to my care'. With the above Oath in mind, the following (false) claims are made by Valneva UK Limited on their website or in the PIL (Patient Information Leaflet), as updated 19th June 2024 regarding their Rabipur 'rabies' vaccine:

False claim 1) 'infectious diseases'

False claim 2) 'inactivated strain'

False claim 3) 'rabies is an infection that can be transmitted'

False claim 4) 'if pregnant you should still be given rabies vaccine'

False claim 5) 'blood tests to measure the amount of antibody against rabies'

False claim 6) 'immune system'

The Rabipur vaccine is produced via purified chick embryo cells (PCEC). Ingredients: trometamol, sodium chloride, disodium edetate, potassium-L-glutamate, polygeline, sucrose and water for injections. Chicken proteins (e.g., ovalbumin), human serum albumin, neomycin, chlortetracycline, and amphotericin B.

Six years ago, when travelling from Holland, we were not permitted to return home to the Isle of Man, unless Bailey was 'rabies' jabbed. Those were, unknown to us then, pet rules; ones that England swore by for any transiting passengers and their pets. But when we study 'rabies virus' science and especially toxic 'rabies vaccine' ingredients - the rules are more than petty: they actually harm pets. We must remember too, of course, that Albert Bourla was a noted veterinarian who moved on to being a key driver of the *safe and effective 'covid' vaccine*, while CEO at Pfizer. Prior to that role he ploughed less fertile ground at Zoetis while promoting the Improvac vaccine. This pig 'inoculation' product seeks to prevent 'boar taint' - the smell that comes from cooking or eating meat, by (unnaturally) inhibiting boar testicular function.
