- 4) Can you provide written evidence of: bird to bird, or human to bird, or bird to human 'avian flu' transmission? (as all 'contagion'/'transmission' studies ever carried out in history, have <u>failed</u>).
- 5) Please confirm in writing if you are claiming that 'H1N1' or 'H7N9' or any Frankenscience 'virus' (or for other claimed bird or animal 'viruses' or 'strains' or 'variants') exist? and that such an entity occurs in an isolated, purified, replication competent form being precisely distinguished in a truly pathogenic i.e. disease causing form, using the Scientific Method with independent variable Controls.
- 6) Please confirm in writing that the 'H1N1' or 'H7N9' or a similar claimed 'pathogenic' entity, is not just simply an assumed in 'silica' i.e. <u>computer</u> constructed model of a: 'bird' or other claimed, 'virus'.
- 7) Please confirm in writing that any claimed 'genome' for any 'avian flu' or other claimed 'pathogen' is not an incomplete 'genome' one' which has not been made up, that is: 'assembled', or 'aligned' or 'smoothed'? to match a presumed model but never found naturally in nature without any tampering.
- 8) Please cite in evidence that any 'test' relied upon for 'avian flu' has a <u>Certificate of Conformance</u> as a <u>diagnostic</u> tool and is not simply an 'amplification' or 'doublification' laboratory research method? Typically known as a 'PCR' (Polymerase Chain Reaction) 'test', or similar as that claimed 'test' has never had a Certificate of Conformance to be capable of 'testing' for any <u>animal</u> or <u>human</u> 'disease'.
- 9) If you, the c<u>laimant</u> rely on a 'PCR' process for 'validation', how many 'cycles' have you deployed? 9a) Is the result of such a process able to be precisely undertaken for accuracy in a r<u>eproducible</u> form? To be valid, such processes must all follow the Scientific Method to ensure 'testing' accuracy.
- 10) Was a <u>defined</u> Control used to ensure that all 'test' results are precise and contain only claimed 'avian flu' particles such that no artefacts of the 'testing' process (calf serum, animal or human cells, growth media, anti-biotics, or other residual matter) have not <u>contaminated</u> any 'avian flu' sample?

There Is Remedy for those who come for Equitable Justice with clear conscience and clean hands.
