

On and For The Manx Constabulary and Manx Court Records

Good day Robert,



You have kindly notarised a number of documents for me, the most recent being: 1) 'HPV' Vaccine Harms Notice, 2) an Opportunity to Cure, and 3) Final Notices as sent to head teachers at five Manx schools: Graeme Corrin (Ballakermeen High School), Keith Winstanley (Castle Rushen High School), Charlotte Clarke (QE2 School Peel), Sonia Taylor (Ramsey Grammar School), and Chris Coole (St Ninian's High School). Most recently no school head nor other public official has been in contact. The only head teacher to write to me regarding 'HPV' vaccine harms was Annette Baker on 13th February 2020 as then head of Ramsey Grammar School. All school heads have been brought into knowledge, as; i) 'Equity shall not allow a statute to be used as a cloak for fraud', and ii) 'Equity acts in personam'.

Despite Oaths of Allegiance: Alex Allinson MHK, Lawrie Hooper MHK, and most recently Derek Flint Ramsey Town Clerk, have impeded or avoided all reasonable and rational attempts to expose truth regarding the criminal poisoning of Ramsey Grammar School pupils via experimental 'HPV' vaccines.

My Emergency Injunction request to Walter Wannenburgh, Isle of Man Attorney General, against 'HPV' vaccinations received a refusal from him by email at 12.12 hours today. The Isle of Man lays claim as 'the oldest parliament on earth' yet flouts The Coronation Oath by the Lord of Mann for an Independent Judiciary so as to serve all people equitably. Without fear or favour or undue influence.

For exposing Manx frauds of: 1) 'virology', 2) of PCR 'testing', and 3) a lack of 'contagion', I have been physically threatened, de-banked by the Isle of Man bank in 2021, and HSBC Douglas branch in 2024.
