

Ian Kermode and lifting the lid 30<sup>th</sup> March 2021

This two page note expands on an open letter dated 25<sup>th</sup> March 2021 circulating on social media. It was authored by Ian Kermode, advocate, of Court View Chambers, 14 Albert Street, Douglas, Ellan Vannin (Isle of Man) IM1 2QA, and sent to Dr. Henrietta Ewart, director of public health, Isle of Man government. The seven page letter by Ian contains 37 items - my summary is six words: No Virus, No Test, No Contagion.

This note has been emailed today 1<sup>st</sup> April 2021 before 11.00am to: Manx public accounts committee members: Juan Watterson, Lawrie Hooper, Jane Poole Wilson, Clare Barber, Julie Edge and Chris Robertshaw as today at 2.30pm they interview molecular biologist Dr Rachel Glover regarding 'covid'.

Below, is my open correspondence reply to the numbered items raised by Ian Kermode in his letter:

On page 1, Ian, you mention 'mumps' vaccine but omit MMR vaccine ingredients (the CDC officially state: chick embryo cell culture, foetal bovine serum, recombinant human albumin, hydrolyzed gelatin, WI-38 human diploid lung fibroblasts, and MRC-5 cells from a 1966 aborted cell line).

As no SARS-CoV-2 has yet been purified nor isolated by any government, including the Isle of Man, question 6 should be the first line of your letter, as all fails if there is: no virus. The rest is plain fraud.

Question 2 cites 'self-isolate' please read: The Contagion Myth by Dr Thomas Cowan to understand the Antoine Bechamp terrain health reality - not the well marketed, germ theory fraud, of Louis Pasteur. There is no contagion around the world, simply hot spots and a criminally complicit media. Witness all: officially, Alberta in Canada has not had a single case of flu this year - total criminality and scientific fraud.

Question 3 cites PCR inventor Kary Mullis. David Ashford has cited PCR as a: 'gold standard test' while on 14<sup>th</sup> September 2020 in front of 100 Ramsey witnesses David cited Dr Mullis as being "she" although at the time of Kary's death in August 2019 he, Kary, remained definitely male. Accuracy matters.

Questions 9 to 16 concern ingredients in 'vaccines' - however these jabs will not be as labelled which is a criminal offence - please refer to my prior work with the Corvelva laboratory findings, over the harms and mis-labelling of the HPV vaccine, among others. None of the lab tested vaccines was as labelled, as was reported to the Treviso, Italian police, and to the Manx police. Who continue to ignore such evidence.

Question 17 raises the issues of primate material used regularly in vaccines (some may prefer red to green monkey cells) - the MMR vaccines are of course labelled (by me) as 'Macaque Monkey Regression' due in clinical trials to the autism like socialisation features and reduced teat suckling primate responses.

Question 18 might help note that these jabs remain in ongoing trials ending between December 2022 and January 2023. The Pfizer-BioNTech vaccine contains mRNA (messenger RiboNucleic Acid). This has never previously been used in a jab. From the jab insert *'The duration of protection against covid-19 is currently unknown. Serious and unexpected side effects may occur. Pfizer-BioNTech covid-19 vaccine is still being studied in clinical trials.'* Refer also to Tal Zaks, the Moderna (Mode-RNA) chief medical officer. In his 2017 TED talk he openly boasts: "we're actually hacking the software of life" with messenger RNA... Madness.

Question 20 mentions 'active' ingredients, while spinning a mixing 'and matching' Russian roulette wheel.

Ian, you mention 'vaccine' or 'vaccinate' or 'vaccination' in numerous questions. The term 'vaccine' is used in error as a 'vaccine' shall evidentially, consistently, and safely: 1) provide immunity, and 2) prevent transmission. It has not been tested for points 1 and 2 so it is at best a 'jab' - but it is not a 'vaccine'. Therefore no one can have been 'vaccinated', nor shall anyone ever claim they can 'vaccinate' anyone.

Questions 23 and 24 highlight the concerns of unlicensed trials on pregnant women. Already, there has been a 366% increase in spontaneous abortions in pregnant women subject to 'covid' jabs (refer MHRA and: [dailyexpose.co.uk](http://dailyexpose.co.uk)). This is no surprise as the Astra Zeneca vaccine contains polysorbate 80 which is patented to cause dog infertility. It was about the issue of HPV vaccine induced Manx infertility that lead

to my first arrest on Tynwald day, 5<sup>th</sup> July 2019. (Please refer to my 23 minute film of Roger Phillips, clerk of Tynwald, in his petition folding 'bottom of the pile' criminal collusion).

Question 27 makes a major assumption that 'contra-indications in combo' are studied for any jab, chemo, medicine or petro-chemical drug test. Jabs are only ever tested against a toxic and mis-called 'comparator' never against a benign/inert placebo. These truly are 'vaccine' trials that would make Dr Mengele blush.

Question 28 highlights antibodies, but stating this surrogate end point of claimed proof of 'immunity' is, just like the PCR 'test', not accurate. The measuring of antibodies (IgA, IgD, IgE, IgG or IgM) is the same as looking at a scar on a body: you cannot tell what, in reality, made the cut - it's simply an imaginary 'proof'. Antibody reductionism is another silo science - one claiming 'mastery' of our majestically complex body.

Question 32 exposes what appears to be a deliberate cover up of vaccine deaths and harms by David Ashford - he was also wilfully evasive on Manx HPV vaccine harms. That is the claim of i courtenay.

Question 33 presumes that yellow cards for 'adverse effects' capture harms. With such toxic ingredients they should be called: expected effects. The Harvard Pilgrim study showed that financially compromised doctors only report around 1% of vaccine harms while honesty would result in their licence suspension.

Question 34 puts the cart before the horse. All jabs are toxic and if you put their ingredients into food you would certainly be jailed. Yellow cards are a carnage cover up, as we all retain our full freedoms to bodily integrity. GPs get a, rumour has it, £12.53 per 2<sup>nd</sup> covid jab. Nurses and school assistants also hide behind 'no liability but only for now Dr Mengele. The 'vaccine' is the only liability free US manufactured product...

Question 37 asks, 'Is the Isle of Man intending and planning to vaccinate all children of school age (4-16) for Covid-19 later this year?' Alex Allinson (doing business as education minister) has no vires over the body of any young man or woman and such penetration with a proven deadly 'vaccine' is medical rape. In attempting to shut down public debate Manx police constables PC 267 and PC 11 visited my home on 24<sup>th</sup> February 2021 to warn me against distributing a two page 'statement and notice' first distributed on 6<sup>th</sup> February. A two minute five second video of the police 'warning' has been shown on German TV. All shall take note of the Nuremberg Code on medical experimentation as new Nuremberg trials are coming.

Knowing there is no proven 'SARS-Cov-2 virus', your letter omitted the toxicity and carcinogenic issues of ethylene oxide, which is used to disinfect the swab, more accurately a blood brain barrier piercing nasal javelin. There is no scientific basis for this, in plain sight, satanically ritual 'procedure' on the ill-informed.

Your letter, Ian, requires further clarification for those unable to speak legalese or who do not have ready access to numerous legal dictionaries. Any advocate or members of the private BAR society shall ensure that justice is served in a transparent and uncensored way. However, Ian, you regularly cite 'persons'. In Black's Law Dictionary 'person' is defined on pages 1378-1382 (alternatively see page 149 of The Covid Con; A Wake, by courtenay-adam-lawrence where 'person' is also extensively defined). It is now time for legal transparency and a return to enshrined lawful activity. i have regularly emailed 12 Manx police over my covid con-cerns (although Gary Roberts and Emily Perkins have requested no more information).

i have no conflicts of interest - being unpaid and independent for research opinions i hold. i once met Ian Kermode in 2019 (please see page 170 of my 1<sup>st</sup> book: From Health Heretic To Common Law Advocate).
