Manx Treason and Silence - Section 1 - Rules of Equity

The Rules of Equity confirm that we are all equal under the law and no one is above the law. These are the foundational claims contained in the 20 Sections of this file dated 13th April 2025.

The Judicature Act of 1883 confirms where Common Law jurisdiction is deficient at bringing justice, then superior Rules of Equity apply and are binding. Equity brings fairness and justice, doing what is right in cases where Common Law is deficient and cannot serve, we, the people.

The Isle of Man, as part of the British Isles, falls under the British Constitution, comprising: the 1688 Bill of Rights, the 1688 Declaration of Rights, the Magna Carta of 1297, the 1701 Act of Settlement and the 1707 Act of Union. All are underpinned by the Coronation Oath taken by the current King Charles III, Lord of Mann. Most crucially as a representative of his people King Charles III promised to: i) govern according to laws and customs of the people and; ii) provide an independent judiciary. Currently these promises are deficient and are being breached daily in Manx Courts, as the people are the source of all law, not the private, for profit, Law Society.

Most importantly, during the recent claims of 'covid' and 'science', under the Rules of Equity:

- 2). All who come to Equity must come with clean hands and clear conscience
- 3). A statute cannot be used as a cloak for fraud

Sir Richard Gozney, then Isle of Man Lieutenant Governor in 2020, falsely declared a 'covid pandemic', by invoking the 1936 Emergency Powers Act to lockdown the Isle of Man for a 'virus' that only existed in the media. Further, despite repeated notifications to the current Lieutenant Governor Sir John Lorimer, John has failed to investigate the legal vires of the 'covid' actions of Sir Richard Gozney. Fraud ab initio has no time limit, not in the legal, nor lawful, realms.

The repercussions of many unlawful 'covid' activities are still, sadly, being experienced on the Isle of Man today. In the final section: Section 20 'Next Steps' we address this requirement, a claim to finally act fairly and transparently, not simply act for powerful, vested interests. Manx Treason and Silence - Introduction

The Isle of Man, situated in the British Isles, is a British Crown Dependency claiming to have the oldest continuous Parliament on earth. It is, therefore, fitting that the people of the Island hold a proper and decent Public Investigation into all things 'covid', as when we look with fresh eyes we shall see there was: no 'virus', no 'test', no 'contagion'. There was no 'covid', nor any 'pandemic'.

To date, English, Scottish and Manx 'covid' Public Inquiries have taken place with claims that lessons were learnt. However, the presumptive terms of reference of each 'inquiry' never sought to uncover the greatest of all foundational lies, by not asking if there ever was: a 'virus' or 'covid'. The 'covid' con resulted in genocidal Crimes Against Humanity so demands full public exposure.

Such a crime is unfathomable to the vast majority of distracted people. The biggest crime in human history was ushered in via relentless 24/7 media propaganda, following a received but hidden script, to induce fear, enabling "jabs in arms" acceptance. But first a 'virus' and 'variant' had to be media promoted for any mass 'new vaccine' to be accepted. It was by design, a very long planned, worldwide control and depopulation agenda, via a new generation of toxic 'vaccines'.

Five years ago today on 13/4/2020, Abbotswood Nursing Home became a focal point of unfolding Manx 'covid', as suspicious deaths of 20 people commenced, aided by unknown State actors. In April 2020 Manx media propagandised a 'killer virus' decimating elderly people in Abbotswood, Ballasalla, Isle of Man. In that way an estimated 65,000 Manx people were later, heavily coerced into taking toxic, experimental, militarily produced 'vaccines' of various types. Resultant carnage will go on for many decades, via a debilitated Manx population which is steadily overwhelming sick treatment services, miscalled Manx 'healthcare'. The Manx nation of around 84,000 people will not heal until we have full public disclosure, not just expensive, whitewashed 'official facts'. We owe it to the coming generations to expose what has taken place, via a Public Investigation.

Identical copies of this lever arch file are being distributed to certain individuals so that a process of true fact finding can commence. These files cannot do justice to the enormous weight of evidence now coming to light, via the slow realisation that there never was a 'pandemic'. All who make such claims shall be required to prove it in public, for open unbiased scrutiny. Any who claim 'transmission' of a 'virus' will, in time, be seen to be lying. In reality, in 2020 the hospitals were never overwhelmed, while many of their staff (or imported others) during 'covid', cruelly took part in mocking dance rituals. By having a Manx Public Investigation we shall avoid future repetitions of the 'covid' con or other newly minted versions of the WEF depopulation agendas.

Being blocked at every turn to bring 'covid' murders into the light, I searched for remedy from institutions set up to give, we, the people, international justice, where Manx justice had failed.

I was introduced to John Pace, an international law lecturer and author of: THE UNITED NATION COMMISSION ON HUMAN RIGHTS'. John was patient with his time and was invaluable helping me draft a 'notice of genocide' document dated 12/12/2023 which was sent to the ICC (International Criminal Court). John particularly drew my focus onto Page 266 (of 845 pages);

Article 5 of the Statute of the International Criminal Court lists the crimes within the jurisdiction of the Court, which included crimes against humanity. Article 7 spells out crimes against humanity as any act:

when committed as part of a widespread or systematic attack directed against any civilian population, with knowledge of the attack (a) Murder; (b) Extermination; (c) Enslavement; (d) Deportation or forcible transfer of population; (e) Imprisonment or other severe deprivation of physical liberty in violation of fundamental rules of international law; (f) Torture; (g) Rape, sexual slavery, enforced prostitution, forced pregnancy, enforced sterilization, or any other form of sexual violence of comparable gravity; (h) Persecution against any identifiable group or collectivity on political, racial, national, ethnic, cultural, religious, gender as defined in paragraph 3, or other grounds that are universally recognized as impermissible under international law, in connection with any act referred to in this paragraph or any crime within the jurisdiction of the Court; (i) Enforced disappearance of persons; (j) The crime of apartheid; (k) Other inhumane acts of a similar character intentionally causing great suffering, or serious injury to body or to mental or physical health.

Please refer to the 26 page ICC attached document in this section for further details. The document was sent to 120 individuals, but three copies were returned, by: Karim A. A. Khan Chief Prosecutor of the ICC, and by Manx advocate Paul Rodgers - and also Manx Police on the orders of Ramsey based Police Sergeant Steve Gadman on 26/12/2023.

Manx Treason and Silence - Section 3 - Legal Overreach

I have witnessed many unlawful actions and omissions by the legal profession on the Isle of Man. Around six years ago I had intended to work with Isle of Man legal specialists Doug Stewart, Nigel Taylor, and Eric Anglin, who all initially displayed a sense of fairness and justice.

Doug Stewart is well known for chairing the 'Dr' Rosalind Ranson Employment Tribunal which awarded 'Dr' Ranson £3.2 million for 'unfair' dismissal as Medical Director to the Isle of Man Government. However 'Dr' Ranson made baseless claims of: i) 'transmission', ii) 'viruses' and iii) 'covid'. Such false claims broke Manx Human Rights Laws when 'locking down' the Isle of Man.

Nigel Taylor was, in 2018, keen to sue the Philippine's Government over harms of Dengvaxia a 'dengue fever vaccine'. This was triggered in part by an HPV vaccine injury to a member of his restaurant staff. When I met the staff member on 17/5/2018 she had already suffered three years of post-vaccine injury.

Eric Anglin was notified on 4th December 2019, that I was hoping to hold people liable in their private capacity for the harms of 'HPV' vaccines. He has since been reluctant to engage further.

Over the years I have contacted Sally Bolton, Darren Taubitz, Victoria Watterson, Ian Kermode, Robert Jelski, Mike Jelski, Phil Games, Winston Tailor, Larry Keenan, Adam Killip, Tom Maher and Paul Rodgers, yet all have failed to expose the 'covid' (depopulation) crime of the century.

The Manx Law Society has relied on keeping hidden the presumed, but unquestioned science, of 'viruses' and 'vaccines'. In my own case by James Robinson Isle of Man Senior Prosecutor, hiding 49 documents of 146 pages supportive in my defence against 'harassment' and 'stalking'. I have been identifying and aiming to prevent Manx crimes for many years and continue to put much evidence into the public, as records show. I never approached, nor 'stalked' anyone, preferring to be peaceful and to put copious rebuttal evidence forward, for open scrutiny, without any bias. Endemic legal obfuscation is aided by a complex medical system, reliant on collective views of 'paid for' science, which is not valid, when we look at 'science' with fresh eyes. All science must be defined by unbiased research, not simply by democracy, nor untested wild presumptions.

Walter Wannenburgh Attorney General, made false claims in Court regarding 'viruses' being proven. Further, he recently refused an Emergency Injunction against 'HPV' vaccination in five Manx senior schools. On Tynwald Day 5th July 2019, Roger Phillips, Clerk of Tynwald, continued obstruction of my 'HPV' Vaccine Deaths Petition. Roger previously, claiming an error, back dated the Word version of the Petition to '2018' (... to be timed out on Tynwald Day 2019?). Jonathan King, current Clerk of Tynwald, recently ignored my Emergency Injunction request, to prevent the February 2025 toxic 'HPV' vaccines programme in Manx senior schools. Shameful.

Manx Treason and Silence - Section 5 - No 'virus'

Medical treason stems from no 'viruses' exist, when we look at how all 'viruses' are 'identified'. The current, decades long process, creates dead tissues, artefacts of breaking down animal cells, antibiotics and added 'medium' that 'scientists' claim are 'viruses'. Without ever being able to prove that a 'virus' can make a well person sick. It is THE fraud of this and previous centuries.

So what made me sick? People ask that, as if that proves any 'virus' exists. Could it be your: toxins, poor habits, location, anger, stress, electromagnetic radiation, alcohol, denatured food, lack of exercise, medication side-effects... but most importantly a lack of knowledge of what makes you sick, or well, as a place to start investigating.

Christine Massey, together with some public spirited collaborators, have asked 226 health boards across 40 countries, if anyone can cite evidence of an: isolated, purified, replication competent, pathogenic 'virus' - one that can make a well person, sick. To date she has compiled 3,000 pages of evidence, all failing to cite evidence in reply to Freedom of Information requests. An 18th February 2021, Isle of Man Government FoI reply to Steven Gardner, could not cite evidence of a 'SARS-CoV-2 virus' on which Manx 'covid' lockdowns and masking and distancing and 'covid' vaccinations were based. But the FoI confirmed 45 PCR 'test' amplification cycles were used, by which a 'positive' can be artificially induced - so as to fit a false 'disease' agenda.

Jamie Andrews is a professional renovator and property investor, having initially studied geology, he has an enquiring mind, calling out anomalies - where things don't add up. To date, he has been running a project commissioning independent laboratories to do 90 experiments studying cell death (cytopathic effects) in the 'cultures' used to prove if 'viruses' exist. Working to a clear Scientific Method, he has gone beyond the research of Dr Stefan Lanka, to show that traditional 'virology' experiments produce the artefacts that lab scientists call 'viruses'. His Control Studies Project aims to falsify claims of 'virology'. Jamie explored this area after his first son had an adverse reaction in 2018, to an MMR vaccine, so started to question his foundational science presumptions of 'viruses' and 'tests' and claimed 'contagion'. When we study his 'experiments', Louis Pasteur, was a cruel animal torturer, with marketing and money at his disposal, but not science skills. Manx Treason and Silence - Section 6 - No 'test'

If ever there was a fraud it was in calling a PCR research process, a 'test'. One without any questions being asked, as to whether an 'antigen test', or a PCR (Polymerase Chain Reaction) process could 'test' for anything. There is no Certificate of Conformance for 'PCR' as a 'test'.

The fraud of PCR 'testing' for a novel 'SARS-CoV-2 coronavirus' came from the Corman Drosten 'test' outlined in a paper by 24 authors. PCR is simply a laboratory amplification tool, the more cycles, the more 'positives' ... are 'found'. There can't even be a negative test as there are no positive 'positives'. It's all fraud. Kary Mullis the inventor of the PCR research laboratory process came clean stating that it was not a 'test', prior to his death in August 2020.

Prior to Dr Michelle Haywood being elected as an MHK she had a career as a scientist. She has used the correct term of 'PCR amplification' in her claims of 'HPV viruses' being present in the 'Manchester Cohort' Paper of 2004. Many questions of 'virus' science cannot be answered by such claims, as, to date 226 Health Boards in 40 countries have failed when asked via Freedom of Information requests to cite evidence of an: isolated, purified, replication competent, pathogenic entity able to cause a well person, to be sick. Manx Treason and Silence - Section 7 - No 'contagion'

If there is no 'virus', there is nothing to 'test' for, so therefore the 'thing', a non-existent 'virus', cannot be 'contagious' nor 'transmissible'.

Many ideas and presumptions can be contagious, without existing or being real.

Page 9, as attached (and page 199) of The Covid Con; A Wake (published on 12/12/2020) needs no update. Those six words still remain true in science - unblemished by fear, favour or finance.

When we look properly, with diligence, all medical 'contagions' in history are media inventions, based on superstitious presumptions. For 43 years the British Cold Unit tried, since formation in 1946, until its closure in 1989, to make a well person sick, via secretions administered by many unnatural methods. This despite nearly 20,000 volunteers coming for 10 day visits was an abject failure of the 'contagion' theory.

Manx Treason and Silence - Section 9 - Police Failure to Act

Over a dozen police, including current and former Chief Constable's have repeatedly broken their attestation to serve the public, by refusal to receive or review evidence, or to investigate: i) Abbotswood, and ii) vaccine deaths, and iii) vaccine harms. I first heard the term: “we’re just disease mongerers” from Dr Hannah Thomas, a Manx based GP, over a decade ago. Manx Treason and Silence - Section 15 - Follow the Money

Across the pond, Edward Dowd, is an ex Blackrock fund manager and has spoken at length on the real reasons for 'covid' as a world-wide currency reset. For that reason, he estimates 60 million people have been deliberately made, long term sick, as a result of 'covid' injectables. A decade ago I worked with Tony Wild, MLC, a gentle, honourable politician.
