### **Treason Is Upon Us - Military Tribunals Vital**

Good day Jonathan,

I received an email from Carlos August-Phillips on 31/7/26 attaching a 99 page Report of 2026 Tynwald Day Petitions. I outline **Manx Treason** below and also attach three further pages in supportive evidence:

- 1). Comment on Petitions - Ruled 'Out of Order', due to these words: **'Treason Is Upon Us'**
- 2). Table of Conclusions Item 26, Courtenay Heading, Subject of Petition; **'Vaccine Harms'**
- 3). My 6/7/2026 No 'virus', No 'test', No 'contagion' Petition; doesn't ever mention **'vaccines'**...

My 6/7/2026 Tynwald Day Petition was viewed by you and confirmed to be 'In Order' by email on 18/2/2026 and contained the words **'Treason Is Upon Us'**, remaining 'In Order' as approved in February

On 21/5/2025 you confirmed receipt of my 350 Page **'Manx Treason and Silence'** file. That file, with an identical copy served on Juan Watterson in April 2025, exposes **Treason** and **Abbotswood Genocide**...

On 3<sup>rd</sup> August 2026 John Wannenburg MHK died after a 'short illness'. You should, as Clerk of Tynwald, investigate in case John **Wannenburg** and Tim Baker had the same **Treasonous** 'covid' hot jab batches? Previously, on 28<sup>th</sup> February 2025, Attorney General Walter **Wannenburg** refused my demand for an Emergency Injunction to stop 'HPV' vaccines in Manx Schools. Flouting the Precautionary Principles is **Treasonous**, as is the wilful cover-up by **Manx Radio's** Beth Espey and **Manx Media's** Adrian Darbyshire

You Jonathan, as The Clerk, were informed by me of **Crimes** on 7<sup>th</sup> December 2018 during a **Manx 'Statins' Committee**. ## **Comment on petitions that are in order**

9. We have anonymised and redacted petition number 1, about family court procedure, because it includes detailed information about other members of the petitioner's family. While we would in principle be entitled to publish all of this, we consider that doing so might cause distress to those family members and there is no need for this. We will make the full text of the petition available to all Members of Tynwald through a private reading room facility.
10. Petition number 6, from Mr Ivan Burton about the Northern Civic Amenity Site, was accompanied by a number of signatures of people other than Mr Burton. These people cannot be counted as petitioners under the Standing Orders of Tynwald because the pages which they signed did not include a copy of the prayer of Mr Burton's petition as required by Standing Order 6.1(9); neither did these pages include a warning about publication of names as recommended by paragraph 15 of the guidance. For these reasons we are not publishing the signature pages.
11. Petition number 10, from Mr Trevor Cowin about Glenfaba House, is a repeat of Petition 2 from 2025. Last year we classified it as lapsed because it had first been presented before 2021. This year we have classified it as in order on the basis that after a petition has lapsed it may be presented again.
12. Petition number 26, from Mr Courtenay Heading, would have been in order had it not concluded with the words "Treason is upon us". This allegation breaches the requirement in Standing Order 6.1(4) that every petition must be respectful, decorous and temperate.
