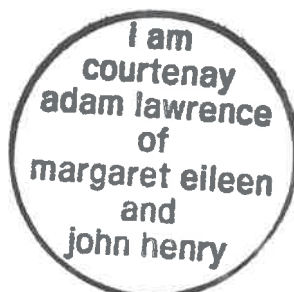

Good day Robert,

Isle of Man Elections due on 24th September 2026 are Invalid by Reason of Treason

Firstly, I was sorry to hear of the death your Wife. You have my sincere condolences at this sad time

- 1). These are difficult days for all as '*Treason Is Upon Us*'. There is much '*legal*' deception passed off as Law
