Dr. Matthew Fogg was born with an identical twin and 8 other siblings in Washington, DC. He holds a Bachelor of Science degree in Criminal Justice Administration from <u>Marshal University</u> and a Honorary PH.D from the <u>Global Oved</u> <u>Dei Seminary & University in Florida</u> for his advocacy on equal justice in all government services. He retired from the <u>U.S. Marshals Service (USMS) and</u> <u>Department of Justice (DOJ)</u> as a Chief with **32** years of federal service while obtaining the highest law enforcement awards from the USMS Director, the <u>U.S.</u> <u>Attorney for the District of Columbia</u>, the Federal Bar Association and others, for service above and beyond the call of duty. He was officially honored with a task force plaque displaying <u>'Batman'</u> for his 'Gotham City' and super hero characterization while on 24 hour call supervising joint USMS/DEA/State & Municipal enforcement operations nationwide.

During his tenure in the USMS he was a member of the Special Operations Group (SOG) aka, SWAT TEAM which, included extensive training in Major Court Security OPS, Scuba Dive Rescue Specialist, Paratrooper, Special Assault Weapons, Hand-To-Hand Combat, Improvised Explosive Devices and Foreign Dignitary Protection for the United Nations, General Assembly. He was cross designated as a U.S. Drug Enforcement (DEA) Special Agent, Group Supervisor with other USMS, state and local Dragnets that captured hundreds of America's most wanted and dangerous fugitives. He was the USMS inspector in-charge of the Foreign Fugitive Unit apprehending many fugitives in foreign countries by networking with the world's largest International Criminal Police Organization known as 'INTERPOL'.

Dr. Fogg was a <u>'First Responder'</u> at Ground Zero on 9/11 in New York City and later, <u>honored by the National Aeronautics & Space Administration</u> (NASA). He is an <u>Ambassador for Peace</u> in the Universal Peace Federation and the Interreligious and International Federation of World Peace and, a former board member addressing racial profiling for <u>Amnesty International USA</u>, the world's largest human rights organization; a former National 1st & 2nd Vice President for <u>Blacks In Government</u> and current President of the BIG Heritage Chapter. He was the only male ever elected as the National President for the FEW <u>Legal & Education Fund</u> and <u>Federally</u> <u>Employed Women(FEW) National Vice President for Congressional Relations</u>.

Dr Fogg is a <u>designated representative</u> for the American Federation of Government Employees Local 1858 and a <u>former candidate for U.S. Congress, Maryland 4th</u> <u>District.</u>

In 1998 Chief Fogg won a landmark <u>(\$4 million) Federal Jury verdict</u> finding that <u>'occult racism'</u> impacted his USMS/DOJ employment dating back to 1985. Later he co-chaired the <u>No FEAR Coalition</u> responsible for promulgating the U.S. Congressional Legislation known as the 2002, Notification And Federal Employees Anti-discrimination and Retaliation Act, <u>('No Fear Act')</u>.

His litigation has officially named **19** U.S. Attorney Generals and today he is the <u>lead Class Agent</u> for hundreds of Black U.S. Marshals, filed in 1994. He has personally represented many other government employees nationwide with <u>EEO</u> <u>Complaints</u> before the U.S. Equal Employment Opportunity (EEO) Commission, the U.S. Merit Systems Protection Board and Union Arbitration. He authored **30** BIG 'Adopted' Resolutions (2005-Present) such as, support for Congressional legislation, the <u>George Floyd Justice In Policing Act of 2020</u>, prohibition of the <u>Washington</u> '<u>Redskins' name</u>, Congressional support for <u>DC Statehood & Equal Voting Rights</u>, Maryland Legislation on <u>Public Safety and Policing</u>, just to name a few.

He received the prestigious <u>NAACP "Barrier Breakers" award</u> presented by House Speaker, the honorable Nancy Pelosi and, the BIG National Meritorious Award for his successful advocacy for internal civil rights in the US/DOJ. He has often testified before the <u>U.S. Congress</u>, State & Municipal assemblies on best practices and/or <u>blowing the whistle on bias law enforcement operations</u>.

Chief - Dr. Fogg is a highly sort after <u>motivational speaker</u>, a national EEO Consultant, law enforcement diversity and tactical operations expert to include the <u>vestiges of racism in government employment and racial bias procedures in the</u> <u>U.S. criminal justice system</u>.

Dr. Fogg is the Executive Director for the Congress Against Racism & Corruption In Law Enforcement (<u>CARCLE</u>), incorporated to support Americas' Whistleblowing COPS on police misconduct. He is a member of the National Organization of Black Law Enforcement Officers(<u>NABLEO</u>) and the <u>Diversity & Inclusion Chair for the</u> <u>Maryland National Parent, Teachers Association (PTA</u>) and a guest law enforcement analyst for CNN, MSNBC, FOX, CCTV, RT and many other news and print media networks.
