MOTHER OF SLAIN SON, BLACK U.S. MARSHALS & CIVIL RIGHTS COALITION INSIST PRESIDENT BIDEN'S EXECUTIVE ORDER 14074 HOLD FEDERAL LAW OFFICERS MORE ACCOUNTABLE

In addition to a 5-25-23, U.S. Department of Justice (US-DOJ) [anniversary report](#) implementing President Biden [Executive Order \(EO\) 14074](#) "Advancing Effective, Accountable Policing and Criminal Justice Practices to Enhance Public Trust and Public Safety" and, following Congressional failure of the [George Floyd Justice In Policing Act](#) -- civil rights activists will conduct a press conference at US-DOJ headquarters in DC asking Biden to direct the DOJ to implement seven key Resolutions below for more effective EO changes in Federal Law Enforcement Agency's (FLEA).

- (1)** Complete the shooting investigation of [Alaunte Scott in Washington, DC](#) and immediately [release videos](#) allegedly depicting [White U.S. Marshals shooting Scott \(Black\)](#) seven times in the back and side, and
- (2)** Immediately meet with [U.S. Marshals Service \(USMS\) Black Class Agents \(Matthew Fogg, et. al. v Merrick Garland, US-DOJ\)](#); order the US-DOJ to **'cease and deist'** 29 years of unresolved internal and external occult racism; allocate \$200 million dollars ([\\$100 million less than \\$300 million demanded in 2008](#)) for 10,000 potential USMS class members; create a Presidential Committee dedicated to "to make whole" ASAP each Class victim in accordance with issues raised from 1994 through today that continually violate the U.S. Constitution, and
- (3)** Take swift corrective action against USMS career managers and follow major recommendations by USMS Class members to prevent future internal bias from lasting three (3) decades that has fostered [vicious external street bias by USMS](#) deputies and other FLEA Agents, e.g. USMS deputies [assault handcuffed Black man](#), and
- (4)** Hold IRS Agency heads totally accountable as a FLEA that has been weaponized to violate the Civil Rights of a USMS Whistleblower and, thousands of Black Americans according to a [recent report](#) and Stanford University Study depicting Black taxpayers receive IRS audits 2.9 to 4.7 times more often than non-Black taxpayer, and
- (5)** Specifically address [Whistleblower rights with consequential protections for FLEA agents who report 'bad' Agents](#); Adopt a full training curriculum to highlight heroic efforts of brave law enforcement Whistleblowers who challenge the Federal *'blue wall of silence'* and, report any form of waste fraud and abuse by FLEA and colleagues knowing that in order to adjudicate crimes in America it is essential to have witnesses, and
- (6)** Set limits on ["Qualified Immunity"](#) for FLEA and Agents as a defense to liability in civil actions on the premise that other public servants, I.E., doctors and lawyers can be personally sued for reckless constitutional violations. This process will greatly deter recruitment and hiring of [racially motivated and/or bias Federal Agents](#), and
- (7)** Create Federal ['Civilian Review Boards'](#) (FCRB) that will oversee any FLEA issues involving civil rights allegations internally or externally and, will operate independently of the U.S. Equal Employment Opportunity Commission. The FCRB will report directly to the Office of the President, understanding that civil rights violations have inherently affected all law enforcement activity in America and has created a lack of trust in Americas entire criminal justice system by millions of people and the purpose for President Biden's Executive Order 14074.

On May 19, 2021, the USMS Black Class Lawyers [wrote U.S. Senate](#) leaders; featured the Class issues in [the 1-26-22 Washington Post](#) and on 1-7-23, Dr. Matthew Fogg, named Class Complainant emailed [President Biden, Vice President Harris, the Congressional Black Caucus and other legislators](#) asking for intervention noting the ongoing Class issues are a threat to National Security and Public Safety. The President and Vice President did not respond nor did the [US-DOJ invite USMS Class Agents](#) with other civil rights groups on 5-18-23 to address Biden's EO.

All activist on 6-7-23 will pledge that US-DOJ's implementation of the seven (7) Resolutions above supporting Biden's EO, will have major impact on ending disparate treatment of FLEA Black agents, Black citizens, and the Black communities that FLEA protect & serve in America.

[The Honorable Carl Snowden](#), Convener of [the Caucus of African American Leaders](#) (CAAL) is appalled that a FLEA such as the IRS is now statistically proven as a weapon against Black Americans in tax audits. "No Federal Agency is feared more than the IRS said Snowden and, this report will have a chilling effect on Black taxpayers. It depicts the untethered power that government officials use to possibly include retaliation against Black Federal Agents who report waste, fraud, and abuse and the report clearly denotes the disproportionate IRS auditing of thousands of Black Americans nationwide."

[Dr. Kimberly Muktarian](#) President of '[Save Our Sons](#)' in Raleigh, NC, said "we are excited that black law enforcement officers are joining with civil and human rights activists to denounce systemic Federal law enforcement racism against Black people. We demand equal justice by President Biden seeking another term."

[Alanta Scott, Alaunte's mother](#) said, she stands in solidarity with parents who face the dreadful reality of having a child killed with deadly force by Federal Agents [operating in a racial hostile environment](#) against Black Americans.

[Dr. Matthew Fogg](#) a retired Chief Deputy U.S. Marshal said, "the President's EO 10474 is the right move for FLEA and it is essential the EO implements our seven proposals above and unequivocally abate the historic reek of [Bigots With Badges](#) inside the lead FLEA/US-DOJ backyard, AKA the United States Marshals Service.

Congress Against Racism And Corruption In Law Enforcement (CARCLE) organized in 1997 following long standing racial divisions in federal law enforcement and USMS rank & file that garnered a [Congressional Black Caucus Hearing with all Federal law enforcement Agency-Heads](#). The Hearing was predicated upon a New York Post featured cover story calling the USMS "[Bigots With Badges](#)"; The news report detailed systemic and egregious internal racial exploits, including White Marshals using Dr. Martin Luther King's photo for target practice, White Marshals running through the Office wearing KKK hoods, abandoning Black colleagues on dangerous fugitive arrest and mocking photos of the death of a young Black girl amongst many other racially motivated incidents, depicting an ongoing [USMS Racial Hostile Environment](#), still unresolved today, as the longest running litigation in America's history.
