# Exhibit "A" – Scope of Services

# 1.1 Scope

The Town of Davie is accepting informal bids for Preventative Maintenance of Dive Equipment, as specified herein. **There shall be no charge for equipment under warranty.** Quantities listed are based on current inventory. Quantities may increase or decrease during the term of this contract.

# **1.2 Technical Specifications:**

- 1. Dive Bottles:
  - a) Visual inspection of all aluminum dive tanks, all sizes
  - b) Check for Hydrostatic date and if necessary, have tank undergo hydro testing, as required by regulations.
- 2. Dive Buoyancy Compensator Devices:
  - a) Visual inspection
  - b) Inflate and check for air leakage
- 3. Dive Masks:
  - a) Visual inspection
  - b) Perform PM on mask while connected to tank
  - c) Check communications system
  - d) Check connections, seals, air diverter
- 4. Labor Cost per hour (to be pro-rated to the quarter hour).
- 5. Percentage Discount from manufacturer's price list for parts.

6. Town of Davie Fire staff will be responsible for pick-up and drop off equipment to be serviced.
