Response to your request for official information

Thank you for your request under the Official Information Act 1982 (the Act) to the Ministry of Health (the Ministry) on 10 September 2020 regarding face coverings.

On 29 October 2020 the Ministry contacted you to inform you that we have extended the due date for your request under section 15A(1)(b) of the Act, as further consultation necessary to complete your response was required.

Information in response to each part of your request is as follows.

1) "What advice has the Ministry of Health issued to the Government concerning the mandating of face coverings on public transport?"

The Ministry has identified six documents in scope of your request. Further information on the documents being released to you can be found in Appendix 1 of this response.

1(a) "What date was this advice issued?"

Information on the dates that each piece of advice was issued can be found in Appendix 1 attached to this response.

1(b) "Exactly what scientific studies are the basis for this advice?"

As part of reviewing international evidence, the Ministry considers other advice from international organisations including: Centres for Disease Control and Prevention, Public Health England, the European Centre for Disease Control and Prevention, Australian jurisdictions, and a range of scientific and medical journals.

The information is collated through Ministry specialist technical advisory groups whose membership include a variety of expert professions such as infection prevention and control, public health, infectious diseases, microbiology, and primary care. When reviewing evidence, we ensure it is applicable to the current New Zealand situation and can be applied in our context.

The World Health Organization (WHO) has published advice on the use of facemasks in the context of COVID-19. This includes an exploration of the risks associated with face mask use. This article can be found at the following address:

1(c) "Who if anybody outside the Ministry was consulted for the development of this advice?"

As noted above, the Ministry utilised international evidence as well as engaging with our New Zealand expertise and advisory groups.

2). "What advice has the Ministry of Health received from the World Health Organisation on the subject of mandating face coverings on public transport?"

As signalled in response to part 1(b) above, the Ministry has utilised advice from the WHO and this guidance has been updated as the WHO produces new advice.

2(a) "On what date was this advice received?"

The Ministry began using the guidance on the WHO website on the day of its publication on 5 June 2020.

2(b) "Exactly what scientific studies are the basis for this advice?"

The guidance published on the WHO website features a reference section. This highlights the 80 sources that informed the proposed guidance put forward in advice document.

3. "What advice has the Ministry of Health issued to GPs and or the Royal New Zealand College of General Practitioners concerning the definition of exempt person for the purpose of the face covering on public transport order?"

Advice was provided to the Medical Director of Royal New Zealand College of General Practitioners (RNZCGP) on 28 August 2020. This advice was issued in the form of an email. This email has been included in the response and further information on the documents being released to you can be found in Appendix 1 of this response. There have also been responses by email to individual GPs and Healthline regarding exemptions. 3(a) "On what date was this advice issued?"

The general mask webpage was last updated on the 21 September 2020. The Q&A was uploaded 15 September 2020. The advice around exemptions was provided by email to the Medical Director of RNZCGP on 28 August 2020 following a request for clarification on 27 August 2020 from RNZCPG.

4) "What feedback has the Ministry received from the Royal New Zealand College of General Practitioners concerning the mask mandate?"

As noted in response to part 3a), there was a request for clarification by the RNZCGP on 27 August 2020. The Ministry acknowledged this email on 28 August 2020.

I trust this information fulfils your request. Under section 28(3) of the Act you have the right to ask the Ombudsman to review any decisions made under this request. Please note that this response, with your personal details removed, may be published on the Ministry's website.
