It was approved as written and accepted.

Maura wanted residents to be reminded to complete 2 proxies, 1 for their association and 1 for the Master. Representatives of the associations on the Master Board should go door to door with proxies to encourage attendance.

## **Committee Reports**

<u>Compliance/Parking</u> – Because of Larry Jones' retirement, 3 candidates were interviewed by the committee of Maria Paige, president, Jerry Allen, vice president and Barbara Gastauer, treasurer. President Maria announced the new Compliance Officer is John Bettencourt, Sr. who began orientation on January 14.

A new phone and email are being established and will be published once completed.

<u>Pool Committee</u> – President Maria reports the pool furniture, chairs and umbrellas, are 5 years old and in need of replacement. Pool House roofs will also be evaluated. Anyone interested in being on this committee, please contact Manager Bettencourt.
