7. Unfinished Business:

a. Snow plowing update: Chair S. Rantala read the response from Christopher J. Blythe, Assistant Attorney General, stating the Attorney General and his office cannot provide the town with a legal opinion. The legal authority of the Attorney General and the Wisconsin Department of Justice is specifically defined, and limited, by laws passed by the Wisconsin Legislature. They may issue legal opinions only as provided in Wis. Stat. §§ 59.42(1)(c), 59.42(2)(b)4., 165.015, and 165.25(3). Under these statutes, they do not have the authority to provide town attorneys or town officials with legal opinions concerning matters such as those the Town described.

Town's legal counsel Linda Coleman, Spears & Carlson, Attorneys at Law, was present to present facts regarding the Town of Oulu providing snow removal on private parking lots. Ms. Coleman stated that it is illegal for any Town to perform snow removal on private parking lots. She also stated that the Town can perform snow removal as long as the Town recovers solely the expenses incurred for the snow removal of private driveways.
