Airport Road TRID Program Project: The Town of Oulu was awarded \$927,112.22 in a Town Road Discretionary Improvement Program (TRID) Project (matching funds) for the repair of Airport Road north of Kaukamo Road to Goetsch Road. The Town would need to borrow the full amount of the project costs and upon completion will be reimbursed half of the project. Motion by D. Reijo, second by T. Egbert to decline the TRID funding due to lack of funding. Motion carried unanimously by voice vote.
