The October 8, 2014 Town of Oulu regular board meeting was called to order at 6:47 p.m. at the Town Hall by Chair Sandra Rantala.

Roll Call: Members present: Terry Egbert, Sandra Rantala, Duane Reijo, Diana Reijo, clerk. Absent and excused: Marjorie Lahti. Town employee/s: Dale Nelson and Jonathan Nelson.

Consent Agenda: Motion by D. Reijo, second by T. Egbert to approve the consent agenda:

- Approve general fund vouchers 11236-11265
- Minutes of the September 10, 2014 regular and October 3, 2014 board meetings. Motion carried unanimously by voice vote.

Treasurer's Report: General Fund \$ 37,622.60 and Tax Account \$ 34,008.03.

Plan Commission Report: F. Strand

F. Strand reported the Plan Commission has completed their review of the Comprehensive Plan and have made changes to the Plan. There are no changes to the Future Land Use map. The Plan Commission recommends and requests that at the November meeting, the Town Board schedule a Public Hearing for January 14, 2015 regarding adoption of the amended Plan. Following the Public Hearing the Plan Commission will meet to consider the public comments and consider a resolution to amended Plan.

F. Strand expressed his gratitude for all the work the clerk put in typing an electronic version of the Comprehensive Plan.

New Business:

Resolution – Designating officials registering voters on election day:

Motion by D. Reijo, second by T. Egbert to adopt the following resolution:

**WHEREAS,** the Town of Oulu, Bayfield County, Wisconsin wishes to comply with Wisconsin State Statue § 6.55(2)(c) which provides that the municipality may provide by resolution that voters go to a readily accessible location in the same building at the polling place to register; and

**WHEREAS**, the current polling place has space available to be set aside for registrations in the same area where the voting takes place that complies with Wisconsin States Statutes § 6.55; and

**WHEREAS**, the integrity of the election process is of utmost importance and will be maintained by this process,

**NOW, THEREFORE, BE IT RESOLVED**, the Town Board of the Town of Oulu, Bayfield County, Wisconsin, does hereby resolve that the registration will be in the presence of the clerk or election inspector; and

**BE IT FURTHER RESOLVED**, the Registration location will be clearly labeled by the town clerk or election inspector.

The town clerk shall property post or publish this resolution as required under s. 60.80, Wis. Stats.

Motion carried unanimously by voice vote.

#### Grader:

Discussion was held on the transmission going out on the grader. The engine on the grader was rebuilt about 5 years ago, steel shavings were found in the transmission and the Board's concern now is how it will affect the hydraulics. A proposal was received from Nortrax giving a quote on a 2014 John Deere grader.

Motion by D. Reijo, second by T. Egbert to purchase the 2014 John Deere grader from Nortrax for \$239,200 at 2.5% interest for 84 months. Motion carried unanimously by voice vote.

### Snowplowing rates:

Discussion was held regarding the snowplowing rate increase that was approved at the August meeting. Following the September meeting the Town Board received a Wisconsin Towns publication regarding increasing service rates. If the rate was increased by \$25 the Board would have to reduce their levy limits by the amount of the increase.

Motion by T. Egbert, second by D. Reijo to rescind the motion for the \$25 snowplowing increase and refund the \$25 already paid for snowplowing by the taxpayers. Motion carried unanimously by voice vote. Supervisor D. Reijo wanted to let the taxpayers know they can donate the \$25 to the town.

Road Maintenance Report – D. Nelson

- Roads are in good shape.
- Wing on the truck is almost done.
- Need to patch the blacktop on Town Line Road by Ruska's.
- The approach to the bridge on Airport Road needs to be raised up.
- Gravel need to stockpile some at the garage
- The bridge on Kaukamo Road was undermined
- Park mower needs a new engine this will be a winter project
