Placing an order constitutes Customer's acceptance of these Terms and Conditions. No signature from Dave The Tire Guy, LLC. is required for these Terms and Conditions to take effect.

3. Customer agrees to pay each invoice in full 30 days after the invoice has been charged on account. Payments are due and payable at the address of 1225 A ST SE, Ephrata Wa 98823.
