Regarding the Beast and the prophesied image, the prophet also first wrote and published his prophetic view, in the late 1980s C.E. (by the commonly mistaken and erroneous Gregorian calendar year designations in current use today), that he has speculated that the beast's image might well be a clone or human-robotic hybrid (cyborg).

This prophet wrote about a time to come when an automated robotic image could move, speak and behave in a fashion that would deceive most people into believing it was a real person, much like the current batch of lifelike robotics that move, appear to speak, and interact with humans as if they have innate intelligence. This was decades before personal computers would finally be capable of convincing animations, or lifelike robotics such as now exist, some of which are being developed to even appear completely human and alive.

The beast power is prophesied to suffer a near-death wound to the head, possibly from an attempted assassination. In Daniel 7:20, 24 we learn that three of the horns, or rulers (Presidents?), will fall due to a little horn with a boastful mouth, the beast; which is another of the ten horns, who will suffer a mortal wound in the head, yet survive (Revelation 13:3, 5-6), followed by a supposed miraculous recovery, probably using the modern technology -- now well developed, which the prophet has said or prophesied since 1985 -- of animatronic/robotic and/or animated special effects images (the image of the beast) as "proof" of this (Revelation 13:12, 15).

The one thing, other than the industrial "revolution," which making an image that can speak and be mistaken for a living person, according to the prophecy of Revelation 13, required was something to sustain the time, experimentation, and expense involved in perfecting such technology.

The modern corporation-fueled "entertainment" industry (starting with Disney's land and audio animatronics creations), mistakenly presumed by a gullible public to be "family" oriented, with multiple million "dollar" projects, and the computerization and miniaturization impetus of the NASA space race, and defense military research and developments, were all required to be in place for this to become a nightmarish reality.

As a result, computerized robotics, some of which have taken the form and shape of their human creators, now move about, seem to talk and reason, and interact with people as if they have "minds" of their own. Can the beast's image be any nearer than it is right now, in the pages of what is actually prophetic history in the making? In case you were wondering, the prophecy more than a quarter century ahead of the fact, of what we now see as reality, and what you have just read, is an example of what has

finally been unsealed. Not even the book of Revelation was entirely unsealed (cf. e.g. Revelation 10:3-4), and even what was not sealed could never be fully understood, before the time came for an inspired individual to give the correct insight into the intended meaning.

It was reported (March 2002?) that a researcher in England has claimed to be the world's first successful cyborg! The report highlighted how he has hooked electrodes into an implant in his arm, and thereby can control remote electrical devices by simply flexing the muscles in his arm. He showed how a light could be switched on by means of his implant, and also how a robotic arm and hand could be made to move in like manner.

He speculated that we are very close to perfecting brain electrodes for the purpose of remote communications and other, more direct, control over computers and external electrical and mechanical devices, using only thought to control them (and being hooked or wired up to a remote controller). With somewhat more insight than usual, the news reporter proposed that this technology could "potentially be put to evil uses," but closed the piece with the typical rosy predictions of a supposed "paradise" made possible by our alleged scientific "saviors."

Yaravsalem was to be surrounded by armies, and utterly destroyed, as it was in 69-70 C.E., approximately 40 years after the Savior's prophetic outline of history (which you will find in the 24th chapter of "Matthew," the 13th chapter of Mark, and the 21st chapter of Luke) foretold it, a harbinger of which was to be the setting up of an abomination in the sacred place of the Temple, something which only the righteous would truly comprehend or understand, causing them to flee the city to save their own lives ("Matthew" 24:15-19; Mark 13:14-17; Luke 21:20-24).

When a walking, talking abominable robotic automaton image of the beast is set up, those refusing to bow down before it, or worship the beast by taking the mark of his name and number (the sign of slaves), to participate in a new digital currency that can be controlled by such symbols (similar to the new encoded squares called "smart codes"), will be executed for a period of 105 days, apparently!

It is apparent from the fact that the beast power will seek a death penalty against those who refuse to bow down and worship his idol, or take his name or numbered mark in their foreheads or hands (Revelation 13:15-17), that some of the laws the beast will change deal with the death penalty. Because of such a change in the international law, superseding the laws of individual nations, countless innocent people will be beheaded, or put to death by guillotine once again, because they will refuse to worship the beast's image or receive the mark of his name or number (Revelation 20:4). Daniel 3:5-7 refers to a pagan observance by the King of Babylon's that involves the prophetic fore-type of the beast's image in ancient Babylon.

The beast power will then do away with the daily offering of morning and evening prayers, at the Al'Aqsa mosque on the former Temple Mount, by descendants of Abraham through Yasmael, setting up the beast's abominable image there, which starts the clock ticking on the 1,260, 1,290 and 1,335 days. The resurrection will take place, most likely at the end of the 1,260 days, during which a small group of faithful elect will be protected in a place of safety, crossing over a body of water to reach it when, like the Pharaoh of ancient Egypt, the beast's pursuing army is lost at sea; as many ships and airplanes before

it have mysteriously disappeared, in locations such as the Bermuda Triangle (Revelation 12:13-16)!

The deaths of those left behind, who are not righteous enough yet to qualify for this supernatural protection of being hidden away during this time, will take place next (Revelation 12:17), which may actually begin on or about the 1,230th day, and last through the 1,335th day (a total of 105 days or 15 weeks, recall), when the Savior and His resurrected elect return to the earth, following the wedding supper of the Lamb, which takes place during this same time before the heavenly Father's Throne, whereupon the beasts and their empire are destroyed.

All churches, and there are an increasing number, calling themselves "worldwide," "universal," "international," or some similar synonym for catholic, are simply stating the obvious fact that they are following this selfsame concept of a "one world religion." All the more so if, like the beast's world-ruling kingdom, they seek to, or do, exercise dominion or authority over the inhabitants of the earth, to force them eventually to bow down to, and worship, a talking image (or android) of the beast (Revelation 13:12).

The world has been led to accept and worship a fake "savior," an image of a man entirely unlike the actual Messiah Himself, whose false pretense will be finally exposed for all to see by the very Sovereign he will falsely claim to be. "All inhabitants of the earth will worship the beast -- all whose names have not been written in the book of life belonging to the Lamb who was slain from the creation of the world" (Revelation 13:8). They will allow fake "miracles" to fool them into bowing down and worshipping the image of this beast, simply because a second faker -- a false priest -- will cause a form of lightning to strike the earth, among other things:

"And he performed great and miraculous signs, even causing fire to come down from heaven to earth in full view of men" (verse 13).

In any case, it appears clear from scripture prophecy, that this technology will eventually be turned against any of us earthlings who refuse to bow down and worship the modern idol or image of the beast, by a second beast, who will come with many deceitful "miracles" to convince the rest of humanity of the supposed "messianic qualification" of the first beast to rule the earth (cf. Revelation 13:13-18)!

Despite these dire predictions of what is about to take place, in the very near future (should you survive long enough to actually see it), there is plenty of hope for the humble, the truly kind, the generous, the meek, the poor and the oppressed. In this world they may not have much hope, for their enemies and foes seek them out and persecute them to death (those who refuse to bow down and worship the coming beast or his image, and refuse to take his name or numerical mark upon their flesh — hand or forehead — without which they will no longer be allowed to buy or sell). A time when, apparently, the guillotine, or another form of beheading, will be the preferred means of execution, once again! (Revelation 13:15-17) Those who patiently endure, and are faithful even unto death, will receive the great reward of being resurrected back to life, in spirit-quickened bodies, no longer capable of dying, at the beginning of the coming new millennium. They will rule with the true Messiah on earth for a thousand years.
