ON 3-31-88 AT APPROX 0900 HRS A GROUP OF APPROX TEN DEMOSTRATORS WERE SITTING ON THE TRACKS IN FRONT OF THE NAVAL WEAPONS STATION ON PORT CHICAGO HWY. THE GROUP OF DEMOSTRATORS WERE ATTEMPTING TO BLOCK A TRAIN FROM CROSSING PORT CHICAGO HWY TO ENTER THROUGH THE FRONT GATE OF THE NAVAL WEAPONS STATION.

LT SIZEMORE ADVISED THE GROUP THAT THEY HAD ONE MINUTE TO REMOVE THEMSELVES FROM THE TRACKS TO THE AREA ACROSS THE STREET. AFTER ONE MINUTE PASSED ALL BUT THREE DEMOSTRATORS LEFT THE TRACK AND STREET AREA THAT ENTERS INTO POST TWO.

LT SIZEMORE THEN VERBALLY ADVISED THE THREE REMAINING DEMOSTRATORS THAT THEY WERE UNDER ARREST FOR 647C P.C. OBSTRUCTION OF STREET OR OTHER PLACE OPEN TO THE PUBLIC.
