Peace Pilgrimage '88 is an act of worship, reflection, edification, and witness. We encourage dialogue with communities along the route.

As a participant in Peace Pilgrimage '88, I agree to abide by the following nonviolent discipline, and, as part of my spiritual preparation for this witness, I will reflect on these commitments:

- 1. As members of the nonviolent witness of Peace Pilgrimage '88 I will follow the directions of the designated leaders. In the event of a serious disagreement I will remove myself from the witness.
- 2. My attitude as conveyed through words, symbols, and actions will be one of openness, friendliness, and respect toward all people I encounter, including police officers, government employees, and those who oppose our witness.
- 3. I will not damage any property.
- 4. I will not bring or use any drugs or alcohol.
- 5. I will carry no weapons.
- 6. Peace Pilgrimage '88 is a legal witness. I agree to obey all laws, including traffic and littering ordinances.
- 7. I will keep in mind that the behavior of each participant reflects on the whole group.
