### Plan Commission Report: F. Strand

Harold Lindelof's special use permit request:

- $\triangleright$  SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>, section 31
- ➤ 40-acre parcel
- ➤ Relocate a one-bedroom house from 70715 Oulu Rock Road
- > Parcel is zoned Forestry 1

#### Findings:

- ➤ Parcel size is 40 acres
- Parcel Future Land Use Class is Forestry Core
- Forestry Core allows the maximum density of 1 building unit complex per 35 acres
- ➤ The Special Use Permit application to relocate a house to this parcel is consistent with the Zoning Classification and the Future Land Use Class for the parcel.

### Plan Commission Recommendation:

- Approve the Special Use Permit application with the following conditions as supported by the Findings.
- > Conditions:
  - No change to the project construction type (new construction, mobile house, manufactured house, recreational vehicle) is allowed without review by the Town Plan Commission and approval of the Town Board.
  - The Town may periodically review the Special Use Permit to assure compliance with the permit conditions and the Town's Comprehensive Plan.

Harold Lindelof's request to relocate a one-bedroom house from 70715 Oulu Rock Road to a 40-acre site at corner of Oulu Rock Road and Bain Road. PIN: 04-038-2-48-09-31-1 04-000-10000. Legal Description SE<sup>1</sup>/<sub>4</sub> SE<sup>1</sup>/<sub>4</sub>; S31T48NR9W. Acreage: 40 acres

Motion by Pedersen, second by Reijo to approve Harold Lindelof's special use application based on the findings and recommended conditions of the Plan Commission. Recommended conditions include (1) no change to the project construction type (new construction, mobile house, manufactured house, recreational vehicle) is allowed without review by the Town Plan Commission and approval of the Town Board, and (2) the Town may periodically review the Special Use Permit to assure compliance with the permit conditions and the Town's Comprehensive Plan. Motion carried unanimously by voice vote.

Motion carried unanimously by voice vote.
